FOR LONGTIME Carmel resident Annette Gatterdam, having one of the best ocean views on the planet comes with a price she never imagined insomnia.

"It's frightening," said Gatterdam of the Carmel River, which is encroaching on the sandy bluffs below Scenic Road near her oceanfront Carmel home of over 50 years. "I've gone out and looked at it at three o'clock in the morning because I wasn't sure if we were going to have a road."

Despite efforts by Monterey County Public Works to drain the Carmel River Lagoon and save a beleaguered landmark cypress tree, a swelling Carmel River continues to erode the bluffs.

Just three weeks ago, public works attempted to shore up the beloved tree,

using a bulldozer to pile up sand around its base and exposed roots. Hardly a trace of their efforts remains today.

"There isn't any sand anymore," observed Gatterdam. "There are two bulldozers down there, but they don't have any sand [to move]."

The two bulldozers are presently sitting on a bluff just below Scenic Road overlooking the swiftly passing river. In recent years, public works cut a breach in the south-

'Cautious optimism,' new jobs, more tax revenue in budget

NO LAYOFFS are called for in the 2005/2006 budget, the city council learned Tuesday, when city administrator Rich Guillen presented the proposed \$11,259,578 spending plan.

"So you can take a sigh of relief," he said.

Last year's decision to eliminate 24 jobs rather than raid reserves was sound, according to Guillen. He described the reorganization of city departments and jobs as effective, except for the need to hire a part-time janitor so library bathrooms could be reopened. Using Carmel historical data and predictions from the state legislative analyst office, Guillen and the budget team of treasurer Charles Reimer, CPA Paul Wood and finance specialist Cheryl Panattoni are projecting increases of at least 3 percent in all three major taxes - sales, property and hostelry. This marks the first time in three years that growth is projected for each of the "big three." "This document was prepared with optimism that the market will continue to do well, but it's guarded optimism," Guillen said, because the state still faces a massive deficit, and the tourism industry is changeable. "This is as bullish as we would want to get," he said. The budget anticipates a total \$9,257,168 in tax revenues — including \$3,147,744 in property taxes, \$1,879,100 in sales tax, and \$3,770,324 in transient

occupancy tax.

ern section of a natural sandbar to help drain the lagoon. This year, the agency tried a different strategy and breached to the north to accommodate a request by the National Marine Fisheries Service, which was concerned that breaches to the south were draining the lagoon too quickly, sweeping young steelhead out to sea.

D.A., sheriff search for child molester on the lam

A LONGTIME resident of Carmel Valley, convicted in absentia Wednesday of molesting a young family member during an eight-year period in the 1990s, is being sought by

Monterey County Sheriff's Deputies and investigators with the district attorney's office so he can serve a term of up to 58 years in prison.

James E. Daly, a doctor of osteopathy who last worked at Salinas Valley State Prison in Soledad, is also facing forfeiture of his \$500,000 bail — money that could come from the sale of his home on Schulte Road, according to Deputy District Attorney Stephanie Hulsey.

"I understand the property is in escrow, and even if he turned himself in, the county could theoreti-

cally get \$500,000 from the sale of the home," she said.

The property, which includes several rental houses, was listed for sale for \$2,195,000, according to real estate records, and escrow will close "very soon," according to a broker familiar with the sale.

Daly, 64, was convicted by a jury of 10 counts of molesting a family member when she was between the ages of 5 and 12. He was arrested last year after an investigation produced evidence that he had committed "continuous sexual assault of a child," according to D.A. investigator Melanie Rogers.

Pope's passing evokes nostalgia for his Monterey Peninsula visit

WITH THE death of Pope John Paul II dominating headlines around the world for the last two weeks, Peninsula residents nostalgically recalled his visit to Carmel in September 1987, when he landed on Larson Field in a heavy helicopter, dined on a Pine Inn-provided lunch at the Mission and presided over a well-attended mass at Laguna Seca.


"I remember having everything prepared and ready to go,

and looking at that huge military helicopter on TV, and then looking up, and His Holiness was walking in the door," said Richard Gunner, who has owned the Pine Inn for 20 years. "It was a surreal moment."

Gunner's inn beat out other local restaurants for the privilege of serving the Pope and his entourage.

Showcasing local ingredients, the lunch menu was developed by then-head chef Doug Robertson and his staff, according to Gunner. The Sept. 17, 1987 meal included corn chowder, artichoke hearts vinaigrette, Monterey Bay poached salmon with butter sauce, asparagus, baby carrots, new potatoes and California fruit tart. Beverages included coffee, Durney Ranch spring water, Calistoga sparkling water, Durney Vineyard Chenin Blanc and Cabernet Sauvignon, Sebastiani Sauvignon Blanc and Zinfandel, and Ernest and Julio Gallo Chardonnay and Cabernet Sauvignon.

The staff prepared most of the meal at the inn and then finished it in the kitchen at the Mission, making the timing quite challenging.

"We went through some trial runs and did some preparation in anticipation, and I think it went fairly smoothly," Gunner said. "Everyone was obviously anticipating his arrival and trying to coordinate the preparation of the food to coincide with his arrival and yet give him enough time to get settled."

Wanting to give Pope John Paul II a unique and appropriate memento of the occasion, Gunner read up on him in advance and learned he was a swimmer. He decided on a pair of Barracuda swimming goggles.

"We had them wrapped up, and then I went up there right

\$590,475 in tax funds saved with \$2,300 fire truck repair

AFTER BEING out of commission for more than a year because city officials thought it would cost too much to repair, Carmel Fire Department's ladder truck returned to service last month. The total bill was around \$2,300 - thousands of dollars less than previously anticipated.

The hydraulic system that lifts the 50foot ladder and water spout had failed in the fall of 2003, and the city received a repair estimate of \$7,200, but had no money for it in the budget. As a result, the truck sat idly by, routinely tested and occasionally used as a regular fire engine while the city hoped for a \$531,487 Federal Emergency Management Agency grant for a new truck with \$58,988 needed from municipal matching funds.

But the city didn't receive that grant, and questions about the truck's status led to a new estimate that came in much lower than the original.

"It turned out to be cheaper because when we did the original estimate, they thought they would have to take the ladder off, and they ended up not having to," said CFD Shift Commander Bruce Meyer, who, with engineer Bill Scott, oversees maintenance and repairs.

"A lot of work on the fire trucks is done by the firefighters themselves, which saves the city a whole lot of money," said building official Tim Meroney, who has been helping with maintenance of the city's fleet of vehicles. "This particular truck is really important for our fire department, because it gets up and over rooftops in our downtown district — it's critical for that."

Some, including retired Carmel Fire Chief Bill Hill, expressed alarm when CFD's ladder and its 1,000-gallon-perminute water spout were unavailable. The fire department's options for fighting anything other than a street-level fire were to hoist the 35-foot ground ladder, which requires three firefighters and reaches only to the middle of a third story, or to call in the ladder truck from neighboring Pebble Beach Fire or another nearby agency.

A citizen offered to donate \$6,800 to help fix it, but the gift was not used,

A PEBBLE Beach guard's tactile instincts led to the discovery of a counterfeit \$10 bill which a pair of apparently guileless New Hampshire tourists used to buy a ticket for 17 Mile Drive. The unfortunate pair ended up taking a trip to scenic Del Rey Oaks instead of the famous drive in Pebble.

"The bill didn't feel right to the guard, and she used one of those pens to see if it was real, and it didn't mark in the right color," Monterey County Sheriff's Sgt. Scott Ragan said of guard Allison Burgos, who asked the couple to wait at the gate while she called the sheriff. "The tourists were cooperative."

Neil Wetherbee, 65, and his wife told deputy Rick Matthews their story.

"They said they received the \$10 bill in change from the 7-Eleven at Canyon del Rey and Highway 68, so the deputy took the people back to the 7-Eleven, and the clerk recognized them," Ragan said. The clerk didn't

remember if he had given them a \$10 bill in change, but he gave them a genuine bill to replace the fake and the Wetherbees caught a flight home soon after.

Ragan said the bill will be turned over to the U.S. Secret Service, as is customary.

Formed in 1865 to fight forgery, the secret service investigates all counterfeit currency, U.S. Treasury checks, Department of Agriculture food coupons and U.S. postage stamps.

According to the service, counterfeiting is among the oldest crimes and was at one time considered treason, punishable by death. During the American Revolution, the British counterfeited U.S. continental currency in such large amounts that it soon became worthless. "Not worth a Continental" was slang of the time and is still heard today, according to the Secret Service website, which said counterfeiting was rampant in the war between the states: "During the Civil War, one-third to one-half of the currency in circulation was counterfeit. At that time, approximately 1,600 state banks designed and printed their own bills. Each bill carried a different design, making it difficult to detect counterfeit bills from the 7,000 varieties of real bills."

The 1862 introduction of a uniform national currency intended to cut counterfeiting, but without much success, which led to the formation of the secret service.

The service advises people to examine their notes for signs of forgery, including fuzzy lines in the portrait, borders, seals and

other embellishments; wrong color, spacing or alignment of serial numbers; odd texture of paper, and the appearance of blue and red threads printed on it rather than embedded in it. Newer bills also have a security strip running vertically through the paper.





EIR on Flanders Mansion attacked for including finances

GET THE discussions of money out of the environmental impact report on the proposed sale of Flanders Mansion, Carmel planning commissioners said Wednesday. That was their chief response to the draft EIR, which was released April 1 and concludes that selling the property would result in several significant unavoidable environmental impacts. The document goes on to evaluate alternatives to selling

capital. "I've been involved in and read a number of EIRs, and this is the only time I've seen an EIR that addresses dollars," chairman Bill Strid said. "Each of the alternatives more or less says they are inferior to the project because they fall short finan-

cially, but there's no statement anywhere what the financial goal of the project is, so there's no benchmark you can use to determine how far short you're falling.'

The city's goal is to sell the historic mansion to someone who will restore it. In the draft EIR, Denise Duffy & Associates articulated the reasons for the sale: "To raise funds for various projects involving repair/maintenance and ADA upgrades to several municipal facilities and to divest the city of a property in need of significant funding for rehabilitation."

It analyzes potential impacts, ranking them as unavoidable and significant, significant but mitigable, and insignificant. Project alternatives include leasing the mansion or selling other city property instead.



BIG BEACH BOOM WAS AWOL NAVY FLARE

A PHOSPHOROUS flare somehow escaped from a Navy vessel and washed up on Carmel Beach Friday afternoon before being blown up by an explosives team from Moffett Field, according to Carmel Police Officer Chris Johnson.

"Two people called at the exact same time to say there was some metal cylinder rolling in the waves at Scenic and 10th," he said. "When we got there, we found one of the people had already pulled it out of the water."

Police and firefighters saw that the metal canister was smoking from one end. It was emblazoned with warnings not to move it and to contact law enforcement or military if

Johnson called the bomb squad from Moffett Field in Sunnyvale to dispose of the flare, and the team arrived about two hours later.

"They said because of how unstable that stuff is, they have to blow it up on scene they don't like to transport it anywhere," Johnson said. It's not that the flare will explode, but the phosphorous could begin burning if shaken or dropped, and once the fire begins, nothing can put it out.

"It burns through metal, and if it gets on you, you pretty much get a hole burned through you," Johnson said, adding that he's heard of two or three flares washing up on other nearby beaches recently.

But the explosives team had to move the

flare from its location in the sand at 10th Avenue closer to Eighth, in order to have it as far away from Scenic Road homes as possible. The beach at 10th is narrow, but it widens out considerably two blocks north.

"The demolition guy said, 'It probably won't blow out any windows," Johnson added.


Officers and firefighters kept the beach cleared 150 yards to 200 yards in all directions while the Moffett team detonated the flare using plastic explosives.

A fireworks-like display of flame and sparks shot 75 feet in the air, Johnson said, and the explosion caused no damage or injuries, though it prompted calls from several alarmed residents in the area.

"It was loud," he said. "Very loud."



Home buying prospectors ready to mine proposed condo rush

LIKE THE "Eighty-Niners" who participated in the Oklahoma Land Rush more than a century ago, a handful of lucky locals may one day be remembered for their role in an event that could be called the Carmel Valley

Condo Rush. If an innovative plan by Rancho Cañada Golf Club owner Nick Lombardo to convert an 18-hole golf course into a 280unit subdivision ever comes to fruition, a condominium in Carmel Valley could be purchased for as little as \$115,000, a sharp contrast to the county-wide median home sale

price of \$620,000. While Lombardo is quick to point out his estimates could rise with the cost of Lombardo

living before the project is completed, prospective home buyers might still be looking at price tags that haven't been seen in these parts since about 1989

"There's something wrong with an area that's such a haven but the work force has to be relegated to living in hovels," said Lombardo, a longtime advocate of lowincome housing. "Twenty-four years ago, it was as obvious to me as the nose on my face — we need to make room for people."

Lombardo plans to offer 140 units, which represents 50 percent of the subdivision, at below-market rates. The inclusionary (affordable) housing is divided into five categories — very low income (17 units);

A proposed 280-unit subdivision to replace one of the two Rancho Cañada golf courses would include 140 units of inclusionary housing for workers in the moderate to very low-income categories.

low income (17 units); moderate income (22 units); workforce 1 (42 units); and workforce 2 (42 units).

Only residents who work in the area bound by the Carmel Unified School District will be considered eligible for purchasing inclusionary units. CUSD encompasses Carmel, Carmel Valley and Big Sur.

The units and qualifications for buying them are:

Seventeen 1,200-square-foot condominiums designated for very low-income housing. To qualify, an individual or household must make no more than \$27,000 annually. Lombardo said the limits could go up as the cost of living rises.

Seventeen 1,200-foot condominiums designated for low-income residents would cost about \$210,000 each. To qualify, an individual or household must not make more than \$37,000-\$40,000.

■ Twenty-two 1,400-to1,500-squarefoot townhouses would be sold to an individual or household making between \$42,000 and \$45,000 per year. Based on Lombardo's estimates, the price tag would be about \$275,000.



Woman faces felony charges in shooting outside home

THE PACIFIC GROVE woman arrested on suspicion of attempting to shoot her husband in front of their Lawton Street home Saturday afternoon remained in jail this week because she hasn't posted \$527,500 bail, but the charges against her have been reduced, PGPD Lt. Tom Uretsky said Thursday.

'We originally sent the case over for attempted murder, because it appeared at the time that she had fired a shot in the direction of where her husband was standing," he said. "But we were unable to determine that, based on the evidence. The expended round was not where he was."

The shooting occurred during an argument between Amy Huse and her husband, whose name was not released. She allegedly fired the single shot toward the house from inside her car. Her husband was standing outside, and the couple's children, ages 3 and 8, were inside the home at the time, Uretsky said.

"The only injuries were to her, and we're not sure how she injured herself," he said. "She had a minor injury to her hand."

Police arrived around 4 p.m. April 9 after receiving several reports of a domestic dispute and gunfire, according to Uretsky.

They found and confiscated assault rifles in the home and have petitioned a Monterey County Superior Court judge for the right to have them destroyed rather than returned to the suspect's husband. Since they are legally owned and registered, the weapons must be given back to the owner unless the court grants that request, said Uretsky, who has yet to hear the judge's decision.

"He can appeal to the court, but our role here is to keep that neighborhood safe and anything we can do to prevent that kind of violence, we will do it," he said.

Huse has already been arraigned, and a preliminary hearing is set for April 21. She faces felony counts of child endangerment, discharge of a firearm at an inhabited dwelling, attempted corporal injury inflicted on a spouse, making criminal threats and assault with a deadly weapon.



Because steelhead are federally designated as a threatened species, a breach harming the fish could be a violation of the Endangered Species Act. Critics of the strategy contend the northerly breach is the cause of the eroding banks.

In an effort to spur officials into action, a group of neighbors has formed the Carmel Point and Lagoon Preservation Association.


"Our mission is to protect the Carmel Point roadways, assure flood protection and preserve the natural beauty of the environment," said Gatterdam's daughter Annette Thorn, who has lived near Carmel Point for over 50 years. "Our immediate goals are to remove the threat to Scenic Road and preserve the cypress tree."

Thorn and her group are hoping to set up a meeting with Fifth District Supervisor Dave Potter, public works officials Ron Lundquist and Vic Lewis, and representatives of other agencies involved in the matter as soon as possible.

"As soon as they can give us a date, we'd like to get everybody in a room and see if we can come up with something that will really work for everyone," Thorn said. "We want to see the fish survive. We want to find a win-win solution. We want to sit down with all the stakeholders, but quickly."

The group has been assured the meeting will happen "very soon," Thorn said.

Thorn believes the erosion that threatens the tree and the

road has reached the point where action needs to be taken by the responsible agencies.

"I've lived here for 50 years and I've never seen the river take so much beach and cliff as now," she said.


Thorn, like many of her neighbors, wonders why public works doesn't cut a breech in a more southerly direction.

Ron Lundquist, interim public works director, said he doesn't believe a southerly breach would be effective at this point.

"The water level in the lagoon is so low that it could take days to move enough sand [to successfully breach the sandbar]," Lundquist said.

While Lundquist acknowledged that erosion along the bluffs adjacent to Scenic Road "is the worst I've seen in 12

P.G. scoreboard proposal makes it to home plate

IN TWO short but sweet words uttered at a hearing April 12, David Prew summed up the feelings of the Pacific Grove Architectural Review Board about a longdiscussed proposal to install a new scoreboard at PG Municipal Field.

"Play Ball," said Prew with a chuckle.

Dennis Tarmina chimed in, joking he would support the scoreboard proposal only if it included a fireworks display for the benefit of neighbors.

It wasn't long ago the scoreboard propos-

al was no laughing matter. Last week's meeting represented a sharp contrast to a PG Planning Commission hearing Feb. 17, when a letter signed by 19 neighbors opposing the new scoreboard was presented.

Among their complaints were the size of the scoreboard, the size of its numbers and letters, and the fear it would be plastered with advertising.

But perhaps their biggest worry was a proposed amendment to the ballpark's master plan, which was adopted by the PG City Council on April 1, 1992.

After the Feb. 17 meeting, the planning

commission asked the recreation department to work out a compromise with the neighbors. If the lack of opposition at last week's hearing was any indication, the talks were successful.

"Once the neighbors understood we weren't going to change the usage of the park, they were okay with the plan," said Don Mothershead, senior recreation coordinator.

Currently the ballpark is used by the PG Adult Softball League, the PG High School girls softball team and the PG Mustang Baseball League for 9- and 10-year-olds. Kids older than 10 are not allowed to play baseball on the field because of a short center field fence (too many home runs) and the concerns of neighbors (too many broken windows).

Mothershead said the word "signage" in the original proposal was not meant to legitimize advertising billboards, but it led to a misconception that spread through the neighborhood.


"It was never our intention to put signs on the field," Mothershead said.

Once neighbors were convinced they would never see a Coca-Cola billboard at their local ball field, opposition to the plan eased.

Neighbors also opposed the installation of restrooms 10 years ago, Mothershead recalled, fearing the improvement would translate into greater usage of the park.

Mothershead said the recreation department hopes to install the new scoreboard in late July after the completion of a Mustang tournament. The new scoreboard will measure 16 feet wide and 8 feet high and stand 8 feet above the ground. Its numbers will be 18 inches high, its letters 10 inches. The scoreboard will be placed in right center field, above the existing fence.

after they got through with their meal and made the presentation to him," Gunner said. "He was just tickled. During all the talks he was having with various Cardinals or whoever they were, he was tinkering with those goggles. It was cute — a real joy to see that."

Gunner, who had a photographer friend document the visit, said everyone on the Pine Inn team considered it a great privilege to serve a man many considered more important than any president or head of state.

A mixed blessing


Longtime photographer and retired Carmel Police Sgt. Pete Poitras, who worked as the department's detective for 20 years, served as the official law enforcement photographer and drove his police chief, Jack McGilvray, to all the sites the Pope visited that day. McGilvray was the official local law enforcement representative and worked for two years with the Secret Service preparing for the event.

"In order to have me at all these locations, the best way was for me to be the chief's driver that day," Poitras said, adding that he was thrilled to capture the pontiff's presence on film.

"I was in front of the line of all the other photographers who were here from all over the world, and most of them seemed not interested in the Pope, but in Dirty Harry and the Pope. [Clint Eastwood] was mayor at the time, and their mission was to get a picture of Dirty Harry and the Pope shaking hands."

Poitras recalled the military aircraft delivering the

Popemobile and other vehicles for the visit, as well as the last-minute need for a motorcade to Laguna Seca because

fog prevented the planned arrival there by helicopter.

"He was a head of state, and was treated accordingly, just like the President," Poitras said. "And his Popemobile is armored."

(An assassination attempt in St. Peter's Square six years earlier left the Pope with serious bullet wounds and nearly cost him his life.)

Before departing, the Pope took time to be photographed with many of the law enforcement officers who had assisted with

his visit. McGilvray, a devout Catholic, was delighted with the opportunity to shake the hand of Pope John Paul II, according to Poitras.

"Jack was last in line and truly someone who really cared. The Pope had his back to him, and just as he turned toward Jack and started to extend his hand, one of his staff brushed the Pope past and into the car," Poitras remembered. "I caught this look of sheer disappointment on Jack's face."

Understanding the letdown, Poitras said his fellow officers managed to obtain an autographed photograph of the Pope for McGilvray, who also received a rare papal blessing upon his retirement from Carmel P.D. in 1994.

"They don't do that for just anybody, but they did that for him," Poitras said.

And he remembered watching the Pope depart from his Peninsula visit that day.


"They flew in a Marine chopper to fly him out of town, and as the wheels left the ground, we all breathed a collective sigh of relief," Poitras said. "We were all very grateful that he came, did what he was supposed to do, and left."







"He was a member of the community for quite some time, and he had a practice in Prunedale and Salinas before working for the Department of Corrections," Rogers said.

Daly has been sought by law enforcement officials since Monday, when he failed to show up for closing arguments. At that point, the judge in the case, Russell Scott, revoked Daly's bond and issued a \$5 million warrant for his arrest.

"We have leads as to where he might be, but I can't go into that because it would jeopardize the investigation," Hulsey said.

During the trial, Daly's attorney, Larry Biegel, sought unsuccessfully to introduce evidence he said would show that the alleged victim had made prior accusations of sexual abuse - allegations that were false, according to Biegel, who plans to seek a new trial because of what he called "blocked evidence."

But Hulsey said "the defendant got a fair trial," and described Scott as "very thorough and very thoughtful throughout.'

The testimony Biegel sought to introduce came from a child "when she was 4 years old," Hulsey said.

Officials said Daly was last seen Sunday by his wife, Rhonda Rene Daly, at their Carmel Valley home. Dr. Daly left a letter which "was pretty ambiguous" according to Rogers, but which may have indicated his intent to flee.

According to the D.A.'s office, Daly was considered a flight risk ever since he was arrested, but a judge denied efforts to increase his bail. "We're utilizing a lot of law enforcement resources to find him," she added. "In a case like this, you have to act fast and cover as many bases as you can as quickly as you can."



Crew travels globe to film environmental series

IN THE unlikely location of a musty old cannery sandwiched between the Monterey Bay Aquarium and Doc Ricketts' Lab, a group of scientists and filmmakers have been seeking to unravel some of the earth's greatest mysteries.

While the cavernous building at 810 Cannery Row might seem better suited for processing fish, the Sea Studios Foundation has produced an ambitious four-part National Geographic series hosted by actor Edward Norton, "Strange Days on Planet Earth." The series makes its television debut with the first two episodes on Wednesday, April 20 at 9 p.m. on KQED Channel 9.

"Strange Days" follows the research of scientists who are attempting to explain and find the correlation between a wide range of

potentially catastrophic environmental events — Why do invasive species cause such havoc? What happens to an ecosystem when the top predators disappear? If we've cleaned up our waterways, why are we still at risk? And how could just a one-degree rise in average temperature have such profound effects?

In October, "Strange Days" was entered in the Wild Screen Festival, taking home the prize for Best Series. The event is billed by organizers as "the world's most prestigious and influential [film festival] for the wildlife and environmental filmmaking industry."

Perhaps an even bigger challenge than satisfying the critics will be winning over the public. Environmental documentaries often tackle complex and divisive issues that don't easily make good entertainment. Does "Strange Days" have the potential to capture

the public's imagination?

We tried really hard not to make this series all gloom and doom," said series producer David Elisco from his office perched on the edge of a dock overlooking Monterey Bay. "We look for solution-oriented stories that show these things are under our control and there is something we can do about [the problems]."

Elisco said "Strange Days" is not a typical environmental documentary.

"The biggest challenge was finding a way to make it accessible for an audience and not have it be like medicine," he said. "I feel we succeeded. When you tune in, it looks like a mystery

series. It takes a while before you can tell it's a program about the environment."

The Sea Studios Foundation is a nonprofit organization created in 1996 to produce a four-part National Geographic television series, "The Shape of Life." Released in 2002, "The Shape of Life" explored how animal life evolved on earth.

"After producing 'The Shape of Life,' we realized we had the opportunity to do something more about the environment," he said. "The Shape of Life' was about the rise of the animal kingdom. This series is about changes in the environment. Obviously the planet is changing, and we're asking if this is something we should be concerned about."

One of the biggest challenges Elisco faced at the beginning of filmin was not knowing how the series would end.

"We started the project with open minds," he said. "We didn't have any heartfelt conclusions. We wanted to see what science had to say.'

One of the chief premises of "Strange Days" is that seemingly unrelated environ-

> mental events around the world are connected. Elisco points to the example explored in the documentary of a dessicating lake in Africa and how that may be increasing the number of asthma cases recorded in the Caribbean. Elisco's crew traveled to the evaporating lake in war-torn Chad.

> "Strange Days" also explores the consequences of global warming.

> "Global climate change is happening," Elisco said. "The temperature has increased. You could argue whether we played a role in [creating the problem], but the real question is, 'What are the consequences?'"

> By advocating action on environmental issues, does the Sea Studios Foundation risk becoming too political?

> "The environment is not a political issue," Elisco said. "It's a quality-of-life issue. You can't argue for dirty drinking water or breathing contaminated air. You can't separate the quality of your life from your environment," he said. "The environment is affecting your quality of life."

Coastal commission set to approve P.B. seawall

PINE CONE STAFF REPORT

AT ITS meeting in Santa Barbara Friday, the California Coastal Commission will likely approve a pair of seawalls to protect the 5th hole at the Pebble Beach Golf Links.

A staff report issued last month calls for dedication of a new public accessway at the south end of the world-famous golf course, providing a new footpath to Carmel Beach. Company officials were apparently set to agree to dedicate the accessway. The item was set to be heard April 15 at 8 a.m.

"The seawalls will be constructed using reinforced concrete with artificial stone fascia to match the adjacent bluff face," the staff report said. Stabilizing the bluff will protect the hole from eroding onto the beach as the bluff naturally retreated, the report noted.

But stabilizing the bluff may also cause the Stillwater Cove Beach to become smaller over the years. The coastal commission staff recommended that the pathway dedication requirement be tied to this presumed loss of beach.

AWOL teen wanted for stealing the family car

A 16-YEAR-OLD Carmel Valley runaway is facing charges of credit card fraud and car theft, according to Monterey County Sheriff's Sgt. Scott Ragan.

A woman who lives on Ned Lane called the sheriff's department April 9 to report her son had run up at least \$80 in charges on her credit cards without permission and, when confronted, stole the family car and ran away from their Ned Lane home.

"The kid came back with the car, but he has since left again," this time without the car, Ragan told The Pine Cone Tuesday. "He's listed as a runaway, but we don't really have anyone out looking for him."

Although the car was returned after just a few days, the sheriff's office intends to file charges against the teen for car theft and credit card fraud.

"When we do find him, we'll probably issue him a citation and he'll have to answer for that," Ragan said.

The case would be handled by juvenile probation, which focuses more on curbing criminal behavior than levying punishment, and Ragan said the department has the support of the teen's parents in pursuing charges against their son. "It's not that they want him to get into trouble, but to get him into the system and get some help," he said.

Time to step forward

BOTH SIDES in the debate over increasing the city's hotel tax can claim victory after last week's vote.

Only opponents of the higher tax, of course, actually won. The TOT won't be raised, because the yes vote didn't reach the required two-thirds threshold.

But proponents of increasing the tax from 10 to 12 percent also won, because most of the town's voters agreed with them, reflecting the effectiveness of the group's campaign: From circulating the initial petitions, to making their case in front of the post office and in letters to the editor, to getting out the vote on election day, they did a good job convincing a large number of Carmelites that tourists weren't contributing their fair share of municipal tax revenues, and that charging an extra \$2 on a \$100 hotel bill would have a negligible effect on the city's economy while substantially improving city services. We congratulate them on their efforts.


However, as we have often stated in the past, sticking somebody else with your revenue problem is a temptingly simple solution that is also simply irresponsible. If the city's infrastructure is decaying, if staffing levels are inadequate, if important city institutions are being neglected, and if more needs to be spent attracting overnight tourists to town — if these things are truly perceived by the electorate as significant municipal problems, then obviously these same citizens wouldn't hesitate to tax themselves to solve the problems. Residents of Carmel can afford to spend anything necessary to keep their city in tip-top shape. If the 56 percent of voters who supported raising the TOT don't start appearing in front of the city council offering to have their own taxes raised, it means they think the city's recent budget deficits weren't really that big of a problem.

Correction, please

THIS WEEK, several local media outlets swallowed hook, line and sinker an announcement from a local activist that his "group," which he claims is based in Carmel, had sued Monterey County for approving the Pebble Beach Company's development and open-space plans. "Carmel group" sounds a lot better than "lone activist from God-knows-where," and that's why he makes the claim. But shouldn't the news media know better than to embellish the circumstances of what is nothing more than one man's blatant exploitation of state environmental laws to harass a landowner and try to overturn a decision of elected officials — officials who got where they are because a majority of citizens voted for them?

And your readers should know that Thomas' group is the one that influenced the county to open the river to the north in 1993, which required expensive repairs to the destroyed beach and re-covering the roots of the cypress tree which had been exposed.

His letter relating to comments from a Mr. Askew about how they opened the river many years ago is hearsay and contradicted by other reports. Askew never worked for the county on breaching the river.

He also quoted Askew as saying Scenic Road is protected by bedrock which is not true based on two facts: 1) a geological report filed at the water management District and 2) our house constructed on Scenic in 1998 has a basement 12 feet below the road and required a cofferdam construction of the basement which is reinforced cement in sand. You could not have been more accurate or timely with your piece on Wi-Fi networks. As a designer and integrator of Wi-Fi and other Wireless networks, I can attest to many opportunities that far surpass "surfing the net" or filing reports. Wireless networks, recently built for many municipalities, provide reliable access to Department of Justice files and other databases critical to mobile law enforcement. These same networks can be integrated with surveillance systems for monitoring public safety and property, online health records that support first-response EMS personnel at the scene of medical emergencies, and reliable communications systems used by public officials during terrorist attacks or natural disasters. Municipalities can often receive federal and state grants to help offset the build-out costs. Connection fees can be charged to casual users, providing an ongoing revenue stream for local government that is clearly more palatable for tourists than an increase in hotel taxes.

It was just one year after the great stock market crash, probably the worst time in history to start a new business. Almost at once they established the policies which carried them through the Depression and which continue unchanged today: (1) Quality. If produce were in any way inferior, they wouldn't sell it. If meats were in any way less than No.1, you couldn't buy it. (2) Service. They delivered, not just to your home but to your icebox...anything from a jar of jam to a \$100 order. (3) Credit. This was a very important commodity in the early 30s, and they used it to establish many long term customer relationships. Some of the accounts reached large amounts, but almost without exception all were collected. WALTER became "Mr. Inside," stocking shelves, filling orders, keeping the books and seeing to it that customers got what they wanted when they wanted it. HAROLD became "Mr. Outside," searching for sources of supply, selecting the best meats and produce from Valley farms, securing the exclusive business of retirement homes, obtaining Carmel's first off-sale liquor license after Prohibition, steadily improving the quality of Nielsen's fabulous wine cellar. 



Council: No more 90-day closeout sales

SHOPS GOING out of business in downtown Carmel will have 45 days to liquidate their inventory, the city council decided April 5. No deliveries will be permitted during the sale, and signs must comply with existing rules, according to the new law, which will return to the council for final adoption next month.

Last Tuesday's hearing followed a March discussion of proposed changes to city ordinances, which permit 90 days for closeout sales and are "cumbersome and difficult to enforce," according to principal planner Brian Roseth.

The law aims to prevent sales "conducted periodically by businesses that have no intention of leaving. They miraculously recover and rely on additional, periodic, going-out-ofbusiness sales as a means of attracting customers," he wrote in his staff report to the council.

Motivated by closeout sales at Dansk, Saks Fifth Avenue, Oxbridge men's store and others — which lasted for months



and, in some cases, involved liquidators funneling warehoused merchandise through the shops the council made it a priority to change the law.

"This hurts the quality of the commercial district generally and damages competing businesses directly," Roseth continued. "Many cities adopt ordinances to control such practices."

As proposed last month, the new law would have restricted closing-out sales to 30 days, eliminated deliveries and prohibited the use of off-premises signs, such as those waived by workers standing at busy intersections.

But with concerns about constitutionality and enforceability, the council sent the draft back to Roseth and city attorney Don Freeman for revision. The new draft eliminates any specific provision on signs - instead holding businesses to existing rules elsewhere in the code and requires any hired liquidation company to also sign the permit.

Violation of the ordinance

would be considered an infraction, punishable by a mere \$50 per day, but Roseth said the new rule also calls for immediate cessation of the closeout sale if the rules are broken.

month, the city council sought to keep stores from hiring 'human signs" to stand at intersections outside the city. It abandoned that provision last week but approved a new law gov-

> "Ninety days is way too long, and I think 60 is too long, too," she said, adding that business owners can also utilize the Internet and auction sites like eBay to get rid of merchandise.

> "I lean toward 45, because businesses still have the freedom to reduce prices for a much longer period of time," councilman Mike Cunningham said. This only affects "what they promote as a closeout period."

> The council unanimously adopted the new ordinance, which is set to return for a second reading and adoption May 3. If approved, it would take effect June 3.

erning other aspects of liquidation sales.

When it first considered new restrictions on closeout sales last

"Ceasing the sale is a much better threat," he said.

The month-long delay in the hearing process also provided businesses a chance to opine. Roseth said they wanted 45 to 60 days for a closing-out sale, rather than the proposed 30.

"It's a little bit of a tradeoff as to the number you pick," he said. "The longer, the more potential damage to competitors, and the shorter, the more difficult it is [to liquidate inventory], particularly for small operators."

In March, antiques store owner Michael Adamson said it would be difficult for him and his wife to unload their inventory within a month if they had to close.

Chamber executive director Monta Potter said most members who expressed concern preferred 60 days, though she said 45 days would be a reasonable compromise.

Councilman Gerard Rose moved to adopt the new ordinance with a 60-day provision, but member Paula Hazdovac lobbied for less time.



The remainder flows from fees, rents, interest income and other agencies, including \$180,000 from California vehicle license fees.

Rather than ask the council to identify specific revenue generators as he's done in the past, Guillen said it should focus on selling Carmel to broaden the overall tax base.

"A lot of the revenue programs have been difficult to deal with," he said. "And the new approach of trying to grow our marketing effort is a sound one."

He again advocated selling unused city property, particularly Flanders Mansion.

(A draft environmental impact report on the planned sale was released April 1 and will be circulated for 45 days for public comment. The planning commission reviewed it Wednesday. See related story.)

To rake in more fee income, the budget proposes increasing rates for:

■ use of a parking stall for a special event (\$15 to \$30); ■ residential parking permit (\$15 to \$20);

■ tree pruning or removal applications (\$0 to \$25);

■ business license tax (\$0.88 to \$1 per \$1,000 gross receipts), and

■ business license tax for deliveries, which is now \$25 to \$60, depending on type of delivery, but would increase to a flat \$60, with unlimited trips.

We're trying to find revenues in every corner," said Guillen, who recommended last year that staff annually review fees to see which might be increased.

The city also installed a credit card payment system that's convenient for customers but costs \$10,000 a year, so Guillen said he would shop for a cheaper bank or else propose spreading those costs across all fees.

Spending remains tight

The budget team based expenses on actual costs for city departments during 2002/2003 and 2003/2004, as well as those projected for the current fiscal year. Many are flat; some call for increases based on cost of living or other "builtin escalators," but none will drop, Guillen said.

The 2005/2006 budget anticipates \$6,762,420 in salaries and benefits — including \$2,183,931 for police and \$1,073,328 for fire — and \$4,497,158 in materials and services. The increase over last year's \$10,950,340 budget falls in salaries and benefits, including the addition of the parttime janitor, another parking patrol officer (which should pay for itself, Guillen said) and a part-time forestry maintenance

worker.

In writing the budget, Guillen said he did not receive many requests from department heads for specific increases, and spending on capital projects remains unchanged.

"Department managers decreased their respective budgets to minimum levels with the goal of maintaining the current level of services," Guillen wrote in his budget message. "If staff is asked to decrease their operating budgets further, it will mean that additional services will need to be reduced."

He pointed to one significant increase over last year: the employee retirement system, which will cost \$200,000 more than anticipated, partially due to the so-called "3 percent at 50" benefit. (Once they reach age 50, police and fire retirees are eligible for retirement pay of 3 percent of their most recent salary multiplied by the number of years they worked, for annual payments up to 90 percent of their former salary.)

"Employee costs just keep rising, whether it's benefits, workers' compensation or retirement," Guillen said. Additionally, expenses include \$50,000 in merit raises for new employees.

He challenged the council to ponder Carmel Regional Fire Ambulance's ongoing cost increases. In 1999/2000, the city's share was \$128,730; the 2005/2006 figure is \$375,977.

Much of that change is due to a pullback in government funding, councilman Gerard Rose added.

Guillen also asked members to consider an "enterprise fund" that would funnel Forest Theater revenues back toward its much-needed rehabilitation.

Fire station rehab costs

Finally, if the council decided to renege on its decision last week to seismically retrofit the firehouse at a cost of \$380,000, it would not have to take \$230,000 from capital improvement reserves, according to Guillen.

During the public comment period, resident Jim Wright asked about the fire station retrofit, which had been anticipated to include some improvements, including better quarters upstairs, new office space downstairs and an ADA-mandated elevator. But with the council's action last week, only structural improvements are planned.

"I'm not advocating that you put the elevator in - I can understand the thought on why you wouldn't do that - so I am asking how the scope of work changed," Wright said.

After several months of hearing the structural shoring would not be as extensive or expensive as anticipated, and the hiring of architects John Thodos and Ivars Lazdins at a todate cost of \$25,000 to redesign the station interior, councilman Erik Bethel said he objected to his fellow council members' seemingly hasty decision to solely retrofit.


"If construction crews are already working, it would be cost effective to make improvements," he said after this week's meeting. "We want to do two things: Make sure the building itself is sound and make sure our firefighters are in a building that makes them most useful and most effective. You can't have a bathroom that doesn't work and people sleeping in sleeping bags if they're going to be good and effective firefighters."

During the meeting, Guillen said he was responsible for the change in scope. Initial reports indicated the structural work would not be as expensive as the anticipated \$400,000, he said, "so we could do other things."

"I instructed the estimator to look at seismic costs, because that was paramount," Guillen said. "So when he came back with \$380,000, that didn't leave us much for improvements, and that's where we stopped."

Council members did not comment on the just-received budget. Guillen asked them and the public to submit written questions by April 26. They will be addressed at council budget meetings set for May 17 and 26.

"Is this really a true EIR? Because not only does it address environmental issues, but financial issues, and it makes justifications based on financial information but without data," commissioner Alan Hewer commented. "Those financial aspects of the EIR should be taken out and put in a separate document."

Impacts articulated

About a dozen people commented on the study, though none of them mentioned finances.

Flanders Foundation President Melanie Billig complimented the EIR consultant in preparing the draft, which concludes selling Flanders conflicts with the policies, goals and objectives of the general plan and Local Coastal Program; hurts public access to parkland, and creates an island of private property in the middle of Mission Trails Nature Preserve which affects "the cohesive structure" of the park. All these impacts cannot be avoided, according to the report.

Significant impacts that could be mitigated include loss of parking, increased traffic, reduced public views, visual/aesthetic impacts, damage to cultural resources or Native American remains, and threats to environmentally sensitive habitat areas, wildlife and hiking trails.

"There are other uses which may better meet the general plan, LUP and zoning code and are more sensitive to the environment," Billig said, adding that the city has "inappropriately focused on Flanders and failed to develop new revenues."

She challenged the inholding of private property in a park as "very bad land-use planning" and said, "You can't sell it without destroying its historicity."

Although they were asked to limit their remarks to the draft EIR itself, many speakers reiterated their opposition to selling Flanders. But Hatton Road resident Robert Morris said the homeowners group supports the mansion's use as a single-family home.

Retired city forester Gary Girard wondered how the sale would affect the adjacent Lester Rowntree native plant garden.

Shirley Humann doubted the city's historic preservation program would adequately protect Flanders.

'The draft EIR reports that the city's historic preservation policies and guidelines, and the Secretary of the Interior's guidelines, somehow protect Flanders Mansion will regardless of future use," she said. "I simply cannot subscribe to this. In the last five-plus years, the city has had a tragic history of not supporting preservation."

Commissioner Robin Wilson excoriated the document as a whole and pointed out the EIR's lack of analysis of changing the zoning from its present designation as improved parkland.

"Both sides are equally ill served by what I see as a very, very insufficient environ-mental impact report," Wilson said.

The draft is available for public review and comment until mid-May, when new questions will be addressed and incorporated into a final EIR. Last December, the city council voted to pay the team of Denise Duffy & Associates and Jones & Stokes \$69,724 to conduct the study, after opponents of the sale said it would trigger the California Environmental Quality Act.

Carmel-by-the-Sea: Cell phone found at the water's edge. Carmel-by-the-Sea: Traffic collision on private property on Torres Street. Vehicle was drivable.

Carmel-by-the-Sea: Monte Verde Street resident reported receiving a call from a subject, who refused to provide his name, regarding the TOT initiative. The caller showed general disgust toward the city council, the mayor, the innkeepers association and the chamber of commerce. No threats of violence were made. The caller only stated it was time for the members of the city council and the mayor to be replaced. The resident wanted it documented for information only.

Carmel-by-the-Sea: Subject reported finding a gray-colored cylinder with the markings, "flammable," and "phosphorus" on Carmel Beach. It also said if located, to notify law

enforcement or the military immediately and not to touch it. Officers arrived and noted the item had been moved out of the surf and onto the beach. The cylinder was also smoking. Fire arrived and the area was secured. Explosives team from Moffett Field was dispatched to the location in order to dispose on the beach and blew up the device. EOD advised the item contained red phosphorous and is used by the Navy, Air Force and Marines as a marking device. It was also considered very dangerous if handled and/or moved. The device was successfully detonated, causing no damage or injuries.

Carmel-by-the-Sea: Victim sustained an injury to the back of her head. There were dry blood stains on the back of her head and shirt. She had been drinking and was disoriented. She was unable to tell officers how or where she sustained the injury. The area was checked and no location where she might have fallen was found. CRFA transported the victim to CHOMP for treatment.

Carmel-by-the-Sea: Engine and ambulance responded to reported flooding on the west side of San Carlos between Fifth and Sixth. Firefighters discovered water flowing into the street from a sump pump, indicating a possible problem in the basement and parking area. Search showed several inches of water in the basement and garage, including the electrical room. This created a dangerous situation with a possible health hazard, so all access points were taped off and warning notices posted. The main water valve was shut off and the sump continued to operate properly. Nothing else could be done at this time. Upon returning to the station, responsible parties were contacted and advised, and a plumber was notified. On follow-up, the building was found free of standing water and deemed safe.




