## Two resignations leave planning department empty

AFTER LOSING two longtime employees within three months, the City of Pacific Grove has found itself without any planners and is relying on a private firm to help out with the city's land use issues.

The lack of city planners, whose responsibilities include processing building permits, ensuring building code compliance and enforcing zoning regulations, reflects a statewide shortage of workers in the profession.

"I'm hoping we will get through this quickly," Pacific Grove Mayor Dan Cort said of the vacancies. "Because yes, there there will be delays caused by a lack of a full staff."

Several of the city's architects agreed. One, who did

## COMPUTER-SAVVY THIEVES HIT INNS

SOMEONE TRIED to steal \$1.4 million from the Inns by the Sea in dozens of computerized transactions that sent funds to numerous destinations, including overseas, according to the Carmel Police Department.

"It's a significant amount of money," said detective Jesse Juarez. "It initially looked like it was going to be that much, but now it's not that much because there was an ability to recover some of the losses."

He would not say how much was taken and said he's working "to determine how exactly it was done."

## The road to Mexico passes through a little-used national park

CHANNEL ISLANDS National Park is the least-used national park in the nation, with only about 30,000 visitors a year. But for boaters, the Channel Islands are one of the most interesting and exciting places to anchor on the West Coast.

Just off the coast of California, the feeling on the islands — Anacapa, Santa Cruz, Santa Rosa, Santa Barbara and San Miguel — is one of great remoteness. When at anchor at any of them, it can be hard to believe the Golden State, with its 30 million-plus people and unbelievable hubbub, is just a few miles away.

In 2003, my wife, Nellie, and I spent a memorable night at Smugglers Cove on Santa Cruz Island, where the phosphorescence in the water was so dense we could watch the fish dashing around the boat, leaving gorgeous trails behind them.

This year, on our October course down the coast, we hoped to visit San Miguel Island, the westernmost Channel Island and the windiest. But we were wary of attempting it.

Carmelite Ken Wiese has visited San Miguel many times on his beautiful Swan sailing sloop and has regaled us with stories of anchoring in

Cuyler Cove with the wind blowing 40 knots and having to deploy three anchors to keep from crashing on the rocks.

We were not eager to share that experience and planned to stop at San Miguel only if the conditions were favorable. We left Port San Luis, in San Luis Obispo County, the morning of Oct. 12 at 4:45 a.m. The early departure would, we hoped, put us into San Miguel before sunset. With this goal in mind, we motored out of the harbor in the early morning dark, somewhat aided by a clouded moon and the lights from Pismo Beach that sparkled off our port side.

We had southerlies all day, which meant the wind was on our nose, and we had to motor sail. Our first goal was Point Sal, and then Point Arguello. We slowly made our way past the four large oil rigs wonderfully named Rene, Hidalgo, Harvest Light and Hermosa. They are enormous structures that were fun to see and apparently very attractive to sea life that like to hang out around their steely legs.

Also, we had a number of whale sightings during the day and several occasions of dolphins dancing off the bow.

# No tax break for owner of historic home

AT A special city council meeting Dec. 19, Lincoln Street homeowner David Hutchings was again denied a property tax break in exchange for maintaining his historic home under a state law known as the Mills Act.

The city's historic resources board and planning staff had recommended the tax break be granted. But this week's decision by the council not to give Hutchings the special status mirrored the council's "no" vote in August. Hutchings challenged that decision in a lawsuit filed in Monterey County Superior Court a month ago but dropped the suit in exchange for another hearing before the council.

Hutchings hoped to convince the council his 71-year-old home — designed by C.J. Ryland, who also drew plans for Sunset Center, the Bank of Carmel and several other notable Monterey Peninsula buildings — should be preserved under a Mills Act contract that could cut his property tax bill by more than half. He pays \$18,380 a year.

According to the act, property owners who commit to 10-year maintenance and upkeep plans can get tax savings to help offset the costs. Hutchings' home is one of only eight buildings voluntarily listed by their owners on the city's register of historic properties, and he is the only owner who has tried to get a Mills Act contract.

"There's a big misconception that Mr. Hutchings' property and the maintenance program he's proposed don't justify the benefit of the Mills Act contract," attorney Sheri Damon told the council.

Enacted in 1972, the Mills Act is supposed to "foster

preservation of residential neighborhoods" by offering incentives to owners of historic buildings, according to the California Office of Historic Preservation. But the act does not require cities to participate. While Carmel has deemed hundreds of homes within the city limits to be historic, it has also put strict rules in places to limit the number of houses that can qualify for a cut in property taxes.

Since Hutchings bought the house in September 2004 for \$2 million, Damon said he has spent more than \$26,000 on exterior improvements, including \$6,349 on copper gutters, and has an extensive maintenance plan to preserve the home in an excellent condition.

The 10-year plan calls for repairing stucco, resurfacing the driveway, rehabilitating shingles, sanding and staining the deck, scraping and repainting lanterns and window panes, rehabilitating steps and railings, and general maintenance. The list also includes items such as cleaning gutters and "monitoring tree roots."

Rehabilitating an historic home can be very expensive, Damon told the council.

"Sometimes replacing a screw in a casement window can be \$150 if the screws are no longer made," she said. "I wouldn't want to own an historic house because I wouldn't want to put up with that. Mr. Hutchings does."

And to offset the city's losses in property taxes — one of the concerns voiced by council members during previous discussions of the Mills Act — Damon and Hutchings proposed the city charge a fee of \$2,000 per year of the contract.

But the council turned aside the proposal, voting 4-0 to reject the contract. Hutchings' house is bigger than allowed

by current zoning on his land, the council decided, and therefore doesn't meet the requirement that Mills Act houses be 100 percent conforming. Damon had argued the exceptions to height and number of stories were allowed by the city's Mills Act criteria.

The vote was a more decisive outcome than the August hearing, when councilmen Gerard Rose and Erik Bethel favored Hutchings' proposal. Bethel has since left the council, while Mayor Sue McCloud and council members Paula Hazdovac and Mike Cunningham voted "no" both times.





# Police, Fire & Sheriff's Log

## Ankle-biting not appreciated

HERE'S A look at some of the significant calls logged by the Carmel-by-the-Sea Police Department, the Carmel Fire Department and the Monterey County Sheriff's Office last week. This week's log was compiled by Mary Brownfield.

### MONDAY, DECEMBER 11

**Carmel-by-the-Sea:** Fire engine and ambulance responded to reported vehicle accident at San Carlos and 10th. At scene, controlled the scene with Carmel P.D., assessed the driver of a

vehicle with moderate damage to the front end, and prepared the patient for transport to CHOMP. Engine returned to station.

**Carmel-by-the-Sea:** Fire engine and ambulance responded to a reported medical emergency. Assisted the medics with the care and transport of a resident with chronic pain. Engine returned to station.

**Carmel Valley:** Resident reported his mailbox being stolen.



# Christmas-hating vandal strikes with spray paint

THE GRINCH paid a visit to Carmel-by-the-Sea a few days before Christmas.

Images of the cranky Dr. Seuss character's face were conspicuously stenciled in bright orange spray paint on walls throughout the city sometime Thursday night or Friday morning, according to Carmel Police Sgt. John Nyunt.

The Grinch's mug was painted in threes below the Carmel Plaza's sign at Ocean Avenue and Junipero Street, along the Paloosh store wall facing Dolores Street, on a wall down the street at Homescares Carmel, on Paloma's in the former Mediterranean Market building at Ocean and Mission Street, across the back of a newspaper rack near that same location, and on the wall of the Sharper Image shop facing San Carlos Street.

"It was a vandal who thought it would be a little bit funny," Nyunt said.

But the police officers, city building maintenance supervisor Bernard Martino and victims weren't very amused, as they spent time and energy erasing the images.

"We did a lot of the cleanup," Nyunt said. "We didn't want it to be a blight on our community."

Martino painted over the last of the Grinch heads on the Sharper Image wall Wednesday morning, according to Nyunt. Police are investigating a few leads but haven't caught the culprits yet.

# New Year's DUI lookout

DRUNKEN AND drugged drivers will likely end up in police custody as beefed-up holiday patrols run through New Year's Day. The California Highway Patrol will have every available officer on duty from Dec. 29 through Jan. 1, as will many local police departments. Seaside P.D. announced it would set up a DUI checkpoint at Del Monte Boulevard and Canyon del Rey from 9 p.m. Dec. 30 to 2 a.m. Dec. 31.

Paid for with state tax dollars and operated with help

from the Marina Department of Public Safety and the Seaside Prevention Coalition, the checkpoint will "educate the public, discourage driving while intoxicated and enforce DUI and other alcohol-related violations," according to SPD.

Last year, 39 people died during Christmas weekend and 44 were killed during New Year's weekend on California roads, according to the CHP. More than 2,000 motorists were arrested on DUI charges.

Anyone who sees a suspected drunken driver should call 911 and describe the vehicle, as well as its location, direction of travel and license plate number.

# Volunteers tackle impassable trails in Big Sur backcountry

AFTER REOPENING a trail from the remote Santa Lucia Memorial Park campground (near Fort Hunter Liggett) to the Coast Ridge Trail, the Ventana Wilderness Alliance is now setting its sights on a network of trails that surrounds one of the most dramatic natural landmarks along the Big Sur Coast, Cone Peak.

Despite frequent criticisms that the U.S. Forest Service tries to buy up more land while neglecting upkeep on the parks it already has, trails in the Ventana Wilderness section of Los Padres National Forest are actually getting better. And nobody is more responsible for completing the sweaty, back-breaking work than the VWA.

"We think people need to get into the wilderness," explained the group's president, Tom Hopkins. "To value and

respect the wilderness, people need to experience it. That's why the trail system is so important."

## A meal fit for a king

A section of the trail from the Santa Lucia campground had been impassable since a 1999 wildfire. Rehabilitation began almost two years ago and wrapped up the weekend of Sept. 23 when seven volunteers graded, cut back brush, repaired erosion and removed 14 downed trees, including a sizable 28-inch specimen.

"The project is a great example of what happens when everyone works together," commented Paso Robles resident Dave Knapp, VWA trail crew coordinator.

The work site was inaccessible to vehicles, but thanks to the support of the forest service's mule team, volunteers were able to relax in relative luxury at the end of each day's hard work. Wine, cheese, chili verde over rice, pasta, chips and guacamole, and homemade chocolate chip cookies were provided to the weary workers.

## Ambitious project aims as high

Standing more than 5,200 feet tall, Cone Peak is considered the highest coastal mountain in the United States (outside Alaska and Hawaii). A network of hiking routes — including the Vicente Flat, Stone Ridge, Gamboa and Cone Peak trails, as well as portions of the North Coast Ridge Trail — surrounds the dramatic mountain. Unfortunately, many stretches of the trail network are in poor shape. But an ambitious project proposed by the VWA could change that.

The project — which will require paying a forest service blasting crew to remove several particularly stubborn trees — is still in the planning stages, but Hopkins is confident his group will get the OK from local forest service officials who are concerned about the impact any project might have on rare plants and archeological resources.

"We hope to be working on the project by spring," he said, despite the lack of federal support for backcountry trails.

"It's frustrating," said Hopkins of the lack of federal funding for local public lands. "Congress won't give [the local ranger district] the money to do their job. They have half the personnel they had 20 years ago, and arguably, they are dealing with more issues now."

In 1996, he won the California State Senior Amateur Championship. He was also a three-time Hawaii State Amateur Champion who was inducted into the Hawaii Golf Hall of Fame in 1997. In addition, Spengler served as president of the Waialae Country Club.

On the professional side, before joining the Pebble Beach Company as senior vice president of golf operations in 1990, Spengler was venue director for the 1984 Los Angeles Summer Olympic Organizing Committee.

From 1984 to 1990, he was director of golf operations at Ohlmeyer Communications Company, producing golf telecasts of PGA Tour, Senior PGA and LPGA events for ESPN and NBC.

## YOUR AUTO COLUMN

**COVERING ALL THE ANGLES**

A vehicle should track straight on a flat, straight road with the steering wheel centered. If the car pulls to one side, investigate the simplest possible cause first – incorrect tire pressure. If that checks out, look for uneven tread wear. If the wear is uniform, interchange the left front wheel-and-tire assembly with the one on the right. If the drifting problem disappears or reappears on the opposite side, a tire is the culprit. Otherwise, pulling to one side may be due to incorrect steering caster, which is an alignment angle that can be adjusted with a wheel alignment. The side with the wheel with the most negative caster angle is the side to which the vehicle will pull.

Our technicians can make sure that your steering is properly aligned. Alignment is important to make sure your vehicle handles in a safe manner. All of our work is done by ASE Certified technicians, and we are also AAA Approved. If you have questions regarding your alignment, or any other automotive issues, please call to schedule an appointment. Please don't wait until it needs to be towed to us.

P.S. It is a good idea to get a four-wheel alignment once a year, particularly if your vehicle has hit deep ruts, curbs, etc.



# Police department recruits 'eyes and ears'

CARMEL POLICE Department's first VIPs — Volunteers in Policing — met the city council this month, but by then they'd probably already seen their elected officials while keeping people out of the Ocean Avenue planters at the Christmas tree lighting or directing traffic during the city's birthday/Halloween parade.

Lee Whitney — known by many as one of the most cheerful employees of Wells Fargo Bank and a member of many service clubs — and retired educator Stuart Miller underwent special training to become CPD's first uniformed volunteers. The duo, whose radio call signs are Victor 1 and Victor 2, will not only help with public events, but disasters or large scale emergencies, and with some tasks at the station.

"These are the first two — the babies of the family," Sgt. Mel Mukai told the city council Dec. 5. Mukai spent about 18 months developing the plan to recruit, train and retain volunteers, borrowing what he liked from VIP programs in other jurisdictions. Mukai said the cities of Sacramento and San Diego have about 300 volunteers each.

Of seven applicants, Mukai said he selected Whitney and Miller for their volunteerism, philanthropy, community service and altruism. They had attended citizen policy academies, passed extensive background checks and underwent 16 hours of additional training, including ride-alongs with on-duty officers. Police services officer Jeff Olinger taught them techniques for using their police radios, and Cpl. Steve Rana helped them learn about traffic laws and directing.

"Directing traffic is the most fun so far," Miller said. "It requires you to be totally present and to make instant decisions."

Whitney said she enjoys aiding the community in a new way. "This is hands-on," she said. "We are the eyes and ears."

Gaining insight into law-enforcement work gave them renewed appreciation for the cops.

"I, who had known nothing about police except what you see on television, was astonished at the range of humanity that is required in police work," said Miller. "Not only do they have to be prepared to confront violent danger at any traffic stop, but a lot of their work is service, and service that can require knowledge of conflict resolution, social work and psychology."

Whitney, who knows many of the police department's staff through her job at the bank, commented, "It encompasses so much understanding and compassion."

Mukai is proud to have Whitney and Miller in uniform on behalf of the department and said he hopes to build the VIP group.



## Airport owners to present new housing plan

AFTER YEARS of false starts, a plan to turn the former Carmel Valley airport into housing is ready to start wending its way through the permit process.

The Delfino family, which has owned the 30-acre property for more than 50 years, is proposing 29 single-family lots of 13,500 square feet each, almost an acre for 10 multi-family residences, and 14.5 acres of open space.

The first step for the project will be the hearing in front of the Carmel Valley Land Use Committee Tuesday, Jan. 2, at St. Phillips Lutheran Church.

The property, which is located in the heart of Carmel Valley Village, was purchased by Peter Delfino in 1953 from the airport's founder, Tiry Ford.

The airport, which opened Dec. 7, 1941, was the world's first residential airpark development, according to the Carmel Valley Historic Airpark Society. Ford reportedly believed that one day small planes would become an affordable transportation option for the general public. He even envisioned a "homes with hangars" community.

Ford's ambitious idea never got off the ground. The day after the airport opened, President Franklin Roosevelt declared war on Japan. In response, Ford put his plans on hold and joined the Army Air Corps. After the war, when it became apparent to Ford that small planes had limited commercial potential, he shifted his focus to developing a "village" around the airport. That development eventually became what is known today as Carmel Valley Village.

Responding to a unanimous recommendation by the Monterey County Board of Supervisors that the airport was not a valuable historic resource, the State Historical Resources Commission determined in 2000 that the airport was eligible for inclusion on the state register of historic places. Meanwhile, about 1,700 Monterey Peninsula residents signed a petition supporting the preservation of the air-

port.

The airport remained open until 2002, when the Delfinos closed it after a series of contentious public hearings.

When the Monterey County Housing Authority considered shutting down the Rippling River affordable living complex three years ago, the agency briefly proposed building a new subsidized housing facility on the airport site. The plan never came to fruition and the housing authority eventually agreed to refurbish the existing Rippling River facility.

The church is located at 8065 Carmel Valley Road, across from All Saints' Day School. The meeting starts at 6:30 p.m.



The loaded guns — a .44 Magnum under


the front seat and two rifles in the back seat — weren't visible, but Bruno admitted having them, Ragan said.

## Mexican folk dancers, jamming blues rockers highlight First Night

FROM ITS dazzling, multicultural opening ceremony, to its electrifying (and electrified) grand finale, this year's 14th annual First Night Monterey promises New Year's revelers a feast of music, color and celebration.

A remarkable collection of creative types — from musicians and dancers, to poets and puppeteers — will descend on downtown Monterey Sunday evening to welcome 2007.

"It's a really big show, so you should try to plan what you're going to see," suggested First Night Monterey executive director Ellen Martin.

And she's not kidding. Sixty acts, at 30 venues, will entertain the celebratory crowds.

According to Martin, the lively opening ceremony at 3 p.m. sets the tone for the rest of the festivities.

First Night begins with "Tonatiuh: Danzantes del Quinto Sol," a performance at Custom House Plaza by 30 children from the Cesar Chavez Elementary School in Salinas who studied traditional Mexican folk dancing as part of First Night Monterey's cultural outreach program.

"This is what First Night is all about," beamed Martin. The folk dancing youths will be immediately followed by a high-energy percussion onslaught, courtesy of the Taiko Drummers from Japan.

"It will be a thrill for all ages," Martin predicted. Later, the grand finale, beginning at 11 p.m., will provide

## The food and wine that made 2006 memorable

SOME PEOPLE chronicle a year with political missteps and celebrity antics. But my moments of passage are always epicurean experiences — many superlative, some mediocre, and in rare cases, borderline life-scarring. In the spirit of nibbling and scribbling, here's a glimpse of the food, wine and personalities that defined my year.

Standbys such as Montrie, Passionfish, R.G. Burger and A.W. Shucks made regular appearances in my play-book, but several new restaurants arose with big promise. In Carmel, David Fink, the local king of haute cuisine, expanded his empire with Cantinetta Luca. On Cannery Row, Tony Tollner and the Downtown Dining crew debuted Willy's Smokehouse, a much needed, casual-yet-quality concept that's making locals and tourists happy. On Lighthouse Avenue in Pacific Grove, David Freppia transformed the former Favaloro spot into Mèlange, a delightful neighborhood boîte and wine bar, while the Cellar Door Chop Shoppe upped the ante for meat eaters. And that's just the short list.

## Gallery honors beloved local artist who can no longer work

THE WORK of one of the Monterey Peninsula's best loved artists, Mary Buskirk, will be presented in an exhibit that opens this week at the Winfield Gallery.

Buskirk, a nationally recognized textile artist, will be on hand when the gallery hosts an opening reception Friday, Dec. 29, from 5 to 7 p.m.

While Buskirk's work has been displayed in galleries throughout the United States, she has actively participated in the local arts community for decades.

In 1976, Buskirk was commissioned to create "By Wind and Sea This Land Was Formed," a series of woven panels, for the new Monterey Conference Center. Buskirk was appointed to the City of Monterey's Cultural Arts Commission in 1992. The same year, she joined the board of First Night Monterey in its inaugural year. In 1993, the Monterey Museum of Art curated solo exhibition of her work at the conference center. In 2001, the Monterey Museum of Art hosted a retrospective exhibition of her work.

Suffering from Alzheimer's disease, the 75-year-old Buskirk is no longer working as an artist.

A native of Mountain Lake, Minn., Buskirk and her husband, Fred, moved to California in 1960, where he accepted a teaching position at the Naval Postgraduate School.



On the local wine circuit, I was on hand for the celebration of Jacques and Janet Melac's acquisition of Rancho Cellars with Willamette Valley (Oregon) Brooks Winery. The late winemaker Jimi Brooks' sister, Janie, lives in Pebble Beach and is doing a tremendous job carrying on her brother's vision. The list of new local wineries was lengthy, including Böté, Caverson Vineyard, Chesebro Wines, Figge Cellars, Mission Trail Vineyards, Parsonage, PGA Tour Wine, Silvestri Vineyards and Szalay Winery. The Monterey County Vintners and Growers Association signed on the services of public relations agency Wagstaff Worldwide to help bring more attention to its three annual events. For the second year running, I was in esteemed company as a judge for the Monterey County Fair's Wine Challenge. November turned out to be a big to-do for wine geeks as the Highlands Inn put its award-winning list on sale. I'm not certain what induced the premature spring-cleaning of the cellar, but anyone who took





the soundtrack for the countdown to midnight. Opened by the tasty blues rock of local favorites, Red Beans and Rice, the finale will morph into an all-star jam session featuring many of Monterey County's finest musicians.

And between the opening ceremony and the grand finale, First Night ticket holders will be treated to eight hours of nonstop entertainment choices. The highlights include:

■ **The Black Irish Band** — one of the best loved of all First Night performers, at the Steinbeck Forum in the Monterey Conference Center. They'll play at 6:30, 7:30, 9 and 10 p.m.

"They really get everybody stomping and clapping and singing along," offered Martin.

■ **Monterey Symphony Brass Quintet** — This gifted local quintet plays music from all eras, by composers as diverse as Bach and Fats Waller. They'll play at Carleton Hall, 400 W. Franklin, at 3:15, 4 and 4:45 p.m.

"They're going to start with the Baroque period, and end with a little jazz and swing," Martin said.

Also appearing at Carleton Hall will be **I Cantori di Carmel**, a local choral group that just celebrated its 25th anniversary. I Cantori presents a cappella renditions of music from the Renaissance to the present. They'll perform at 6:30, 7:15 and 8 p.m.

■ **Crabapples** — If you like to dance, but the electrified decibels of the Whalewatchers or the All-Stars are too much for your eardrums, you might consider visiting the Crabapples in the Masonic Lodge Hall, where they'll play traditional Appalachian folk dancing music at 6:30 and 7:30 p.m.

There's fun for kids as well. Masten, a longtime Big Sur resident, isn't worried about the possibility of wet weather, despite a soggy Christmas season.


"The weather report always says it's going to rain on First Night," Masten recalled. "And it never does."

not want to be identified because his comments might make it harder for his clients to get permits, called the vacancies at city hall a "major crisis" and complained it's "already hard enough to get anything done in Pacific Grove."

In October, the city's associate planner, Sally Rideout, who had been with city for eight years, left for a private firm. Barbara Nelson, a senior planner who had been with the city for 20 years, left in December to take a job with the City of Seaside.

"There appears to be a demand for planners up and down California right now," said Jon Biggs, the city's community development director, "so we are competing with other jurisdictions and consulting firms for good candidates."

Carmel Planning Services Manager Brian Roseth doesn't have any planners, but he agreed the Peninsula's high cost of living makes it tough to fill vacancies. His two assistants, Sean Conroy and Nathan Schmidt, were hired from Utah and Indiana — which means they weren't familiar with the numerous "peculiarities of California planning law," Roseth said.

## 'We couldn't close any deals'

With the work piling up, Biggs said he's picking up the slack by taking work home and getting up earlier than usual. "While we are recruiting, Jon is filling in at the counter," said P.G. City Manager Jim Colangelo. "We also have entered into a contract with EMC, a local planning firm, to help out until we get some new staff."

While the high cost of living on the Peninsula often deters job candidates, Biggs and Cort said there are pluses to working for Pacific Grove, a city with complicated zoning ordinances and building codes.

"Our codes protect a lot of resources," Biggs said. "So someone interested in lending their skills to the protection of resources I think would be an incentive to work for the city. It's certainly not a place you would be pigeonholed into doing one thing. There are a variety of planning issues that could end up on your desk."

Working in Pacific Grove as a planner "requires you to use everything you've learned," Cort said.

While the city did receive a good number of responses from prospective applicants, Biggs said they just couldn't close any deals.

"We identified two people to offer positions to," he said. "The first person ended up declining because of the cost in the area. By the time we offered the position to the second person, they received a job offer from a private firm and had taken that job."

A qualified applicant would have a college degree in planning, architecture, geography or public administration, and would be familiar with the California Environmental Quality Act and state planning laws, Biggs said.

"We want somebody with some experience in current planning and long-range planning," he said.

Long-range planning encompasses the county's general plan, Local Coastal Program and other documents that give general direction to the city's growth and development. Current planning involves zoning ordinance enforcement, historic preservation and architectural review.

Pacific Grove pays from \$5,068 to \$6,159 per month for an associate planner, while a senior planner can make \$5,470 to \$6,650 per month.

But until planners can be hired, it's likely things at the community development department will move more slowly than usual.

"We are moving forward with the current planning," Biggs said. "The long-range planning is what is being put down lower in the stack."

### MEN WHO EXERCISE LIVE LONGER

Men who are physically active cut their risk of heart disease morbidity in half regardless of what their blood cholesterol levels are. The reason that fitness reduces cardiovascular risk is that all the risk factors that make up metabolic syndrome are sensitive to exercise. "Metabolic syndrome: means having three or more of the cardiovascular risk factors: abdominal obesity, high levels of blood fats called triglycerides, low HDL ("good") cholesterol, high blood pressure, and high blood glucose. Metabolic syndrome, even without high LDL ("bad") cholesterol, doubles the risk of cardiovascular death. Fortunately, the new study shows that, if you want to avoid metabolic syndrome, lead a physically active life. Being active only takes thirty minutes a day, five days a week.

Exercise helps you live longer by reducing your chance of death from causes other than just heart disease. For example, several studies have shown that colon cancer is reduced 30 percent in individuals who exercise regularly. Another advantage of exercise is its positive impact on the treatment of depression. ## Charles Alfred Mohler

1913 - 2006

Charles Alfred Mohler passed away earlier this year at age 93 after a brief illness. A child of the depression, wounded in World War II, then a successful novelist and book editor, he was solidly a member of the "greatest generation."

Mohler first saw Carmel in the waning days of W.W.II after being sent to Monterey to recover from injuries sustained in the Battle of the Bulge; he was an officer in the U.S. Army's "Rainbow" infantry division, fighting the retreating Germans across France. Mohler met his future wife, Hazel Genevieve Dale - at the time a director of the USO in Monterey - in the stacks of the local library. The two were soon married and made their home in Carmel for most of the next 50 years.

Mohler's novella The Jesus Complex was published in 1951 by Story Press. His next three novels all feature Monterey Peninsula settings. A Year of Monday Mornings (Beacon Press, 1959) ends on Carmel Beach; the fictional characters of The Hill (Prentice Hall, 1970) are protagonists in the battle over building the freeway from Monterey to Carmel. Throughout this time, Mohler also worked as a freelance journalist. His travel articles appeared in Sunset magazine, San Francisco Chronicle, Dallas Morning News and other publications, and with his young family he traveled throughout Europe, the Caribbean and other locations. Mohler was a disciplined and driven writer who worked at his typewriter most every day of his adult life. In 2000, he published his final novel, Love is for Pros, a mystery set in Carmel and Pebble Beach.

Mohler also enjoyed a successful publishing career. Beginning in the 1960s, he worked as an editor for a string of major publishing companies, including W.W. Norton, developing college textbooks. He spent a year in New York as a vice-president for McGraw-Hill. During the '60s and '70s, he helped create many successful textbooks in the social sciences, including archeologist L.S.B. Leakey's Unveiling Man's Origins.

He was a lifelong athlete. As a high school student in Des Moines, Iowa, Mohler was State Champion in tennis and received a three-sport scholarship to the University of Virginia. He was the winner of numerous tennis tournaments around the country and, after W.W.II, played number one for the Pomona College tennis team. He took up golf in his 50s and spent many happy hours on the courses of Monterey Peninsula Country Club. He carried a low handicap well into his 70s and was twice match play State Champion of California. He won golf championships in Australia and Portugal and played until age 91.

He is survived by his wife, Hazel, of Truckee, California, son Charles C. (Chaco) and granddaughters Makaiah and Taysa, of Tahoe City, California. The family asks that any donations be given to the Veterans of Foreign Wars, [www.vfw.org](http://www.vfw.org).

We passed notorious Point Conception — sometimes called the Cape Horn of California — at least five miles offshore and had no trouble with the wind or the waves.

(Fierce gales in this area can be common. Three years ago, we passed Conception much closer in, with top wind gusts hitting 47 knots.)

South of the point, the winds are generally calmer. But one of the southern islands, San Miguel, is known as the Windy Island and is an exception to the reduced winds. In October, we approached the island from the northwest, heading to Harris Point. We had to stay to port to be sure to remain well off the unmarked Wilson Rock. By the time we were close to Harris Point, it was obvious conditions at San Miguel were calm and inviting.

## Stuck in the kelp

When we reached the cove, we had to turn to starboard to get into the protected part of the harbor because a large sea of kelp blocked most of the entrance. Despite our maneuvering, we ended up getting a ton of the nasty stuff wrapped around the prop. When Nellie tried to accelerate in either forward or reverse, the boat shuddered like a wet sea dog. We

were stuck in the kelp.

I got the boat pole and, lying on my stomach, hung over the stern with our sailing companion, Tanya Keen, holding down my legs so I wouldn't slide into the drink. I poked, pulled and pushed the kelp off the rudder and prop as best I could, dislodging great gobs of the stuff while Nellie, intermittently, and at low rpms, backed the boat out of the mess. Once we were free, she simply stopped and let another ton or two of kelp drop off of the boat thanks to gravity.

She then maneuvered around the kelp and got us into the anchorage, where we anchored as the sun went down. Safely at harbor, we could take a deep breath and soak in the incredible beauty of San Miguel Island.

## Four palm trees

A Carmel historian, Lois Roberts, has written the definitive book on this exotic destination. "San Miguel Island: Santa Barbara's 4th Island West," available from amazon.com for \$9.95, examines San Miguel's geological past, the introduction of plants and animals, and its human history.

Needless to say, the book piqued our curiosity. Fortunately, a National Park Service ranger gave us a way to satisfy it.

At about 8 a.m. we radioed the ranger station to see if we could go on one of the daily nature hikes. The ranger, Ian Williams, welcomed us to a 10 a.m. hike that would include the crew of the boat anchored next to us, Drambuoy. He told us to land our dinghy next to four palm trees on a beach which was right off our stern.

The morning dawned sunny and relatively warm. We left our boat, Athena, with the V-Berth and main cabin hatches open for ventilation, rowed in and landed our dinghy in small surf, paddling like mad between breaks.

Once on the beach, we had to hike a long way up a sandy slope. At the top of the swath, the ranger, the Drambuoyans, and Rich and Julie Cooley of San Mateo, were waiting. (The Cooleys berth their boat at South Beach Harbor near AT&T Park in San Francisco. They were cruising the Channel Islands for a couple of months with the goal of getting home by Thanksgiving.)

The planned hike was six miles. Unfortunately, Nellie and I could not do all of it, as we wanted to get to Santa Cruz

Island by dusk. But on the first part of the hike, we learned about the coreopsis, which looks dead this time of year, and then rejuvenates in the rainy season and blooms prolifically in the spring. An interesting aspect of island flora is that there can be many unique plants. This is true in the Channel Islands, including Catalina.

Ian was an excellent guide, giving us a good picture of the history of the Channel Islands and the devastation during the sheep growing times on San Miguel Island (as many as 9,000 sheep, chewing up everything).

Despite the devastation to native plants, the island pioneers have to be viewed as dreamers and doers — an entertaining group of characters well described in Roberts' book.

We hiked to a summit with magnificent views of the harbor below. As we hiked back to the beach and the dinghy, the skies began to darken.

mine how exactly it was done."

"Somebody was able to access certain files and was able to take an undetermined amount of money," he said.

A representative from Inns by the Sea, which manages five properties in Carmel as well as hotels in Half Moon Bay, Santa Cruz, Capitola and Santa Barbara, reported the suspicious transactions Nov. 28.

Juarez began looking into the thefts and forwarded the information to the Federal Bureau of Investigations.

"I'm not at liberty to discuss the details," he said. "But there are a bunch of different ways for bad guys and gals to try to take people's money away from them."

He warned people not to respond to any questionable e-mails, including those claiming to be from banks or online retailers soliciting information. Legitimate correspondence will include names and other personal information, not generic greetings such as "Dear Bank Customer."

And when banking online, people should always make sure they're using a secure site — indicated by "https" at the start of the Internet address, as opposed to "http" — and look for the little lock symbol in the upper right-hand corner of the window bar.

"And if there's any doubt, contact the bank at the phone numbers you normally use," Juarez said. "If you notice any suspicious activity on your statements, contact the bank immediately."

# Editorial

## The appeal of repeal

ANYBODY WHO'S raised children knows that Jean-Jacques Rousseau was wrong. There is no such thing as a "noble savage." Parenting, it often seems, is about teaching the little ones not to do things they were born wanting to do.

The legal system views the entire human race much the same way. There is no need, after all, to pass a law prohibiting something nobody wants to do. But legislatures and assemblies around the globe busy themselves making it illegal for people to do things they otherwise would like very much to do. And many of these laws go far beyond the basic principles of the Ten Commandments. It will soon be illegal in California, for example, to use a cell phone while driving. In more than 35 states (including this one), children now have to ride in a booster seat until they are almost 5 feet tall. Etc., etc.


But it goes much farther than that. In most Peninsula communities, the approval of city hall is needed for things such as the color you paint your house, what you plant in your yard, whether you can cut down even a small tree, and so forth. All these regulations are based on the same principle: That even in private or trivial matters, the behavior of humans must be controlled, and that without this control, our communities will become degraded.

The irony is that many of the same people who demand the most control of what people do now revere even the humblest works of humans who lived in decades gone by. Back in the days when you could build whatever kind of house suited you on your property, the result was a wide variety of styles, sizes and shapes. These days, historic preservationists want all of them protected by a government mandate, even as they demand new laws making it impossible for the same type of creativity to continue to exist. The result, even in "creative" communities such as Carmel, is cookie-cutter homebuilding, with every streetscape consisting of the same basic elements.

Thankfully, the pendulum has started to swing the other way. As we pointed out last week, the decision by the Carmel Historic Resources Board that the Golden Bough Theater does not have to be protected was a good example. Even humans who are alive today have something to contribute, it turns out. A new theater may actually be better than the old one!

But with the New Year, and all of the new laws that will be taking effect, we would like to recommend the same approach be used more at the state and national level. In fact, we'd like to see somebody run for Congress or the Legislature on a platform that every day in office will be spent looking for laws that deserve to be repealed, and regulations that need to be rescinded.

### The fly in the ointment of Sunset Center

Dear Editor,

After starvation in the besieged city of Leningrad, during WW2, kids matured very quickly. In 1944, I learned that a kid's brass band would be started at some place and brought there a group of classmates, fourth graders. When my turn came to receive an instrument the only option left for me was a tuba. Seeing my disappointment the teacher said "Savva, you will thank me for this. It is a guaranteed piece of bread." It was a cogent argument and, indeed, I played in different orchestra till university graduation. My mom, school teacher, never had to pay for my summer vacation.

One summer when I was fifteen years old our orchestra couldn't make it and the camp

administration offered me a job working as a leader of a "Young Pioneer detachment" — around 20 boys age 7 to 9 — on the same no-salary basis. This was a

calamity for the poor boys that I will never forget. I felt like a military commander who was entitled to a total subordination of the "squad." We marched in a column and played war games. Disobedience was punished. Don't forget that it was just after the end of the war. Rather soon the kids complained and I was properly fired from the job to their relief. Instead, I was appointed trumpet-caller, which I did almost professionally, and everybody was happy.

This shameful story came to mind in relation to my volunteering as an usher at Sunset Center. I have been doing this since 1994 when I retired from DLI. I well remember Hilda and then Elizabeth, nice ladies in charge who did a great job and who treated ushers with a great respect. I don't know why Sunset Center fired Elizabeth and replaced her with John Newkirk around one-and-a-half years ago, but John definitely reminds me of myself when I was 15.

Never before were ushers required to dress up in a uniform — white top and black bottom with a blue ribbon across an often-sticking-out belly. No jackets are permitted, even in winter. Guests should know that you are not an assistant to them but a servant. "You are under my command and I should be able to easily locate each of you anytime." But somehow simple "Usher" badges were sufficient during the preceding

10 years. By no means ushers should mingle with the "patrons." They are on duty like soldiers. During entr'acte, ushers must stay at their positions. I was reprimanded by John twice: for going out for a smoke during the intermission and for behaving "too informally" — for hugging my friends the "patrons." At least five ushers must hang out in the lobby during the beginning of a performance waiting for late arrivals — why not one or two? Also, during the performance, at least three ushers must count the ticket stubs. I don't know who needs it, but it can be done not during the concert.

Sunset Center is a great cultural facility. There is nothing wrong in scheduling 20 ushers for each performance. Usually there is enough free space in the hall, and excessive scheduling is an appropriate safety factor, but all volunteers whom I talked to hate the uniform and the indignity. Hey, we are coming to do the necessary job of ushering, to help the guests in exchange for enjoying music, and we have always done our job with respect to the guests and to ourselves.

In the meantime, John has "forgotten" to mail me the program for the next season — to select performances that I would like to usher at.

**What the library needs**

Dear Editor,

In response to your article on expenditures for the Harrison Memorial Library, I would like to make the following comments:

You note that the library is "unique" in its costs per city resident. "Its per person expenditures (are) more than five times the national average." However, Harrison's service area is much larger than the city of Carmel; it includes the unincorporated area surrounding Carmel, parts of Carmel Valley, Pebble Beach, and borrowers from other nearby areas.

You continue: "How much tax dollars should be spent on the library?" In this respect I would like to note that private donations account for over 41 percent of its support, a very unusual amount for a public library. Nor is it accurate to use the city population as an index of its expenditures.

I am a volunteer at Harrison Library and a retired librarian from another state. I note that the Goss report recommends more volunteers. However desirable volunteers may be, they are not a dependable source of workers: we have other commitments and responsibilities. Cooperation among libraries is a better choice.

The Goss report is right to recommend a universal library card for all three Peninsula libraries, and its other recommendations warrant further study. There is much value in

communities working together to support libraries and other services if carefully planned. Unfortunately, local pride has often prevented this. And I would like to add that state support of public libraries in California is inadequate as compared with other states.

**Something to be proud of**

Dear Editor,

Rippling River is a great Christmas/Holiday story. Most residents have been resettled into newly refurbished and improved apartments. The next phase of reconstruction will be completed before spring.

A combination of federal rules, state laws and financing regulations made it impossible to return the residents to their old apartments. Accordingly, the residents decided they would select their new apartments, with priority based upon the length of time that they had lived at Rippling River.

Some residents were/are anxious about moving to a new apartment. This is understandable, especially given the age and frailty of many of Rippling River's population. But no tenant has been evicted from Rippling River because of the reconstruction.

One tenant did receive an eviction notice that required her to move to another apartment at Rippling River. After the building was ready for occupancy and she saw this apartment, she was satisfied. Further, experience to date is that the residents quickly adjust and come to prefer their new units.

It is something of a miracle that the disabled and elderly residents, together with volunteers from Carmel Valley and eventually the commissioners and staff of the housing authority, were able to save Rippling River.

In fact, this is the first time in the nation's history that public housing residents and the surrounding community have banded together to save public housing. It also is the first time that a housing authority was able to get the federal

government to waive certain rules to allow the housing complex to be saved.

We all can be proud of our accomplishment.

**Resident seeks seawall**

THE DEL Monte Forest Land Use Advisory Committee will review a proposal Thursday, Jan. 3, to build a seawall to protect against an eroding coastline.

He hopes to obtain a coastal development permit which would allow construction within 100 feet of sensitive habitat, on slopes greater than 30 percent, and within 750 feet of a known archaeological resource.

The Pebble Beach Community Services District building will host the public hearing, which starts at 3 p.m. The building is located at Forest Lake and Lopez Roads.
