MOMMA KEEPS HER EYES ON ALL THE BABIES

THREE YOUNG great horned owls rescued this summer in various parts of the county by the SPCA will soon be ready for release back into the wild, thanks to a wise and loving surrogate mother who was badly burned by a power line several years ago.

The orphaned owls, who were saved after becoming separated from their families, were all raised by Momma, the resident matriarch owl who for years has taught young owls at the SPCA's Wildlife Rescue and Rehabilitation Center how to hunt for food and perform other birdly duties.

"Once we have gotten the babies through their serious health issues," SPCA spokeswoman Beth Brookhouser told The Pine Cone, "they go out with Momma, and she teaches them how to be real owls."

Momma was brought to the SPCA with a horribly damaged wing. "It had to be amputated, but we were able to keep her healthy," Brookhouser said. "And she does very, very well."

Because owls easily lose their fear of people, which is

Pèpe will run for mayor — if he can find a home in town

RESTAURATEUR AND successful self-promoter Rich Pèpe is considering taking his business acumen to Carmel City Hall by running for mayor in April 2012 — even though he doesn't live here. Yet.

"The one caveat is that I have to move into town. Our house in Pebble Beach is on the market, and hopefully we can either get it sold or rent an apartment in town in time to qualify to run for mayor," he told The Pine Cone this week.

The Pebble Beach resident is best known locally as the owner of Little Napoli and Vino Napoli on Dolores Street and two bakeries on Ocean Avenue, as well as the new Vesuvio at Mission and Sixth. He is also involved in Pèpe Winery in Napa and Pèppoli restaurant in the Inn at Spanish Bay, and sells jarred pasta sauce under the name Pèpe & Pants, named for him and longtime friend Joey Pantoliano.

"I have had meetings with some community leaders, and while no final decisions are made yet, I am exploring the options," he said. "But moving into town in time to run could be my biggest hurdle."

The talk of Pèpe's prospective 2012 campaign began during Concours Week last month, when he posted a photo of CHP motorcycles parked in front of Vesuvio and wrote, "Now that I am running for mayor of Carmel, I have the CHP

Well loved realtor Roger Parkes dead at 62

LONGTIME CARMEL resident and realtor Roger Kenneth Parkes — whose community involvement was practically a full-time job in itself — died of cancer this week, leaving behind a crowd of coworkers, friends and family members who sung his praises and remembered his kindness.

"Roger was a kind, gentle and compassionate fellow, much loved by everyone, really," recalled Rita Lewis, Coldwell Banker Del Monte Realty's vice president and managing broker. "Never said a bad word about anyone."

She also said he loved living and working on the Peninsula — to which he moved as a child with his parents from the San Joaquin

Valley — and "always said it was so beautiful, you don't even need to go away for vacation."

In his online company bio, Parkes wrote, "I truly love the Monterey Peninsula, and I always enjoy sharing my knowledge of the area with out-of-town clients and friends. It's kind of funny, but my first part-time job was right across the street from my Ocean Avenue office. I couldn't imagine living any-

where else."

Realtor and Pine Cone columnist Paul Brocchini said Parkes, a close friend with whom he served on the Forest Theater Guild board of directors, was "an extremely witty guy."

"He seemed to know every song lyric ever written, could quote amusing lines from scores of plays and movies, and just was a fun person to be with," he said.

Brocchini also commented on Parkes' capacity for caring for others.

"I had a major surgery a year ago, and he brought me meals and took the trouble to walk with me around Carmel as I was trying to rebuild strength," he said. "That is a true friend."

Born in Madera on May 29, 1949, Parkes moved to Pebble Beach with his parents in 1963, and he graduated from Pacific Grove High School. His father, Kenneth, was also a realtor — a field Roger Parkes entered more than two decades ago and thrived in.

In his biography, he said he spent eight years with "the oldest real estate company in Carmel," Carmel Realty, before joining Del Monte Realty in 1995. A year later, the firm was acquired by Coldwell Banker, and Parkes enjoyed being designated as a Previews Property Specialist and having membership in Coldwell Banker's International President's Elite — the company's top 1 percent. He also won the Monterey County Association of Realtors' prestigious John Leo Award for Excellence.

"Agents loved working on a sale with him, as he was so

Fraudulent tax credits provide windfall for illegal immigrants

■ Taxpayers give away more than \$4B

MOST OF the illegal immigrants living in Monterey County who filed income tax returns last year probably used an IRS loophole to fraudulently claim refundable tax credits, according to a report by the U.S. Treasury Department. Nationwide, the illegal credits claimed by undocumented immigrants cost \$4.2 billion in 2010, the study said.

The report, by the Treasury Inspector General for Tax Administration, found that 72 percent of illegal immigrants across the country who filed income tax returns — which the law requires even though they are not authorized to work in the country — erroneously

Big Sur musician moves to Poland, returns a movie star

IN A hard-hitting and critically acclaimed new movie about a Taliban fighter on the run, the U.S. soldier who interrogates the terrorist is none other than David Price, whom many locals know from his roles as a bass player for the Broadway Blues Band, a stage manager for the Monterey Jazz Festival and operations manager of Big Sur's Esalen Institute.

The film, "Essential Killing," will be screened Saturday, Sept. 10, at the Henry Miller Library in Big Sur.

Price — who lives in southwestern Poland but is visiting the Monterey Peninsula for the jazz festival — has one of the few speaking roles in the movie, which stars Vincent Gallo and was directed by Polish filmmaker Jerzy Skolimowski. Released last year, it won

Best Film at the Polish Film Awards and Special Jury Prize at the Venice International Film Festival.

How Price managed to make it from Big Sur to the Silver Screen without the requisite stop in Hollywood is an unlikely — and unexpected — story. In fact, nobody seems more surprised by Price's success as an actor than Price himself.

"I never really had any aspiration to work in films," conceded Price, who is the son of Esalen co-founder Dick Price. "It was just a fluke."

A film career wasn't part of the plan when Price moved to Poland in 2007, in large part because his wife, Kasia, is a native of the Eastern European country. The two met at Esalen and have a young son, Aleksander.

But shortly after moving to Legnica, Poland, four

Condi buys condo at Spanish Bay

DON'T BE surprised if you see former Secretary of State Condoleezza Rice playing a round of golf in Pebble Beach or perusing a few shops in Carmel these days.

According to the Monterey County Assessor's Office, Rice — the 66th United States Secretary of State under President George W. Bush and also the first woman to serve as National Security Adviser — purchased a \$2.2 million, condo at Spanish Bay last Thursday.

Rice, a professor of political economy at the Hoover Institution at Stanford, has visited the Peninsula numerous times. In September 2010, she was the biggest name on the ticket of the Carmel Authors & Ideas Festival. She signed copies of her 2010 memoir about her family and life growing up in Birmingham, Ala.

Rice is also an avid golfer, which could have been the driving force in buying a home here.

In a June interview with Golf Digest, Rice was asked if "any particularly great or memorable" golf shots stood out.

"Oh, sure, I've had lots of memorable shots," she told the Golf Digest reporter. "The first time I played Pebble — the only time I've played — I really hadn't been playing that long, and I parred the first hole, and then on the par 4, the 4th, I drove the green. And then I 3-putted for a par because I was so nervous on the eagle putt."

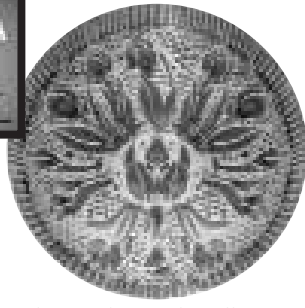

Ex-Tiffany worker seeks big bucks in 'racism' lawsuit

■ Mexican woman claims supervisor called her 'beaner'

A FORMER employee of Tiffany & Co. in Carmel has filed a wrongful termination lawsuit claiming managers of the high-end jewelry store subjected her to a racist "campaign of discrimination, harassment and retaliation," primarily because she is Mexican.

The former employee, Ruth Herrera, claims in a lawsuit filed Aug. 26 she was denied promotions, refused meal and rest breaks, and a sales manager at the store frequently targeted her ethnicity by making fun of her accent and calling her a "beaner."

Herrera — who is seeking compensatory and punitive damages — is claiming discrimination, hostile work environment, retaliation, breach of contract, wrongful discharge, improper commission withholdings and other charges.

She claims the alleged treatment by her supervisors has left her with severe emotional distress and suffering from "anguish, fright, horror, nervousness, grief, anxiety, worry, shock, humiliation and shame." She contends she has lost wages and benefits as a result of the way she was treated.

Though a Tiffany & Co. spokesman in New York City declined comment, its website states it's an equal opportunity employer with a policy to "employ, compensate and promote," regardless of age, gender, race, religion, color, creed, national origin, citizenship, marital status, sexual orientation or disability. The renowned jewelry business has been in

operation since 1837, and its Carmel store opened in 2005. Herrera — who states in the lawsuit she "immigrated to the United States from Mexico" — claims Tiffany hired her in September 2007 at \$14 per hour plus commission on sales

with promises she would sell a lot of jewelry at the Ocean Avenue store.

Police & Sheriff's Log

Someone's been sitting on her couch

HERE'S A look at some of the significant calls logged by the Carmel-by-the-Sea Police Department, the Carmel Fire Department and the Monterey County Sheriff's Office last week. This week's log was compiled by Mary Schley.

TUESDAY, AUGUST 23

Carmel-by-the-Sea: Dog found loose on Mission Street in the commercial district. Dog returned to owner at CPD at 1150 hours.

Carmel-by-the-Sea: A Mission Street resident reported she was having problems with her husband. She left her home for a week due to verbal arguments and was going to return home today. She was given information on how to obtain a restraining order and instructed not to stay at her residence if she does not feel safe or comfortable.

Carmel Valley: Employee reported being punched by another worker. He did not desire prosecution but wanted the incident documented.

Carmel-by-the-Sea: Driver was stopped on Highway 1 for a moving violation and found to be intoxicated. The 32-year-old male driver submitted to a breath test and was transported to county jail, where he was lodged.

Carmel-by-the-Sea: A Dolores Street business owner found a loose dog and attempted to contact the owner via the information on the collar. Animal control officer was also contacted, and the dog owner responded to the business, where the dog was returned to the owner with a warning.

Report pushes fire merger with Monterey

EVEN THOUGH it's not the cheapest option, Monterey should take over Carmel's fire department, according to the latest analysis of options for operating CFD. The city council is set to discuss interim city administrator John Goss' recommendations at its Sept. 13 meeting.

"Monterey is already satisfactorily overseeing and administering Carmel Fire and its staff, apparatus and equipment operating as part of a five-station system," he wrote in the report released Sept. 2. "In many respects, an operational merger with Monterey already has been achieved."

The city has paid Monterey Fire's chiefs to oversee Carmel's department for the past few years and has received more benefits than anticipated, according to Goss, who also said other agencies and cities that have hired Monterey, including Pacific Grove, have been happy with the results.

He credited Monterey's leadership with fixing numerous broken fire hydrants, assisting with the fire station remodel and seismic retrofit, reducing combustible materials in Mission Trail park, replacing old fire vehicles and obtaining several grants to purchase up-to-date emergency equipment and tools.

It's especially meaningful that Carmel's firefighters also support the idea of a Monterey takeover, according to Goss.

"Most often, the success or failure of any merger is contingent upon the cooperation of employees," he wrote, adding that fire crews "feel that the current leadership of Monterey Fire has changed Carmel Fire to a much more professional, highly trained, better equipped, integrated fire operation."

In addition, working with Monterey has cut overtime costs and helped familiarize MFD crews with Carmel.

If the city went in a different direction and merged with the state agency Cal Fire, Goss said Carmel firefighters are concerned they would not receive pay raises and would have to work longer hours — 72-hour shifts, compared with the current 56-hour shifts.

"Because of their support for merger with Monterey Fire, Carmel firefighters have publicly indicated that they will

Teens arrested in brazen gin theft

TWO 19-YEAR-OLD Pacific Grove residents were arrested Aug. 23 and 24 after one of them allegedly stole a bottle of Tanqueray gin from the bar at Spanish Bay and the other assaulted the hotel employee who chased him.

Bogart Pieper stole a bottle of gin worth \$99 from the bar, put it in his pants and walked out of the hotel, followed by the manager who noticed what he had done, according to Monterey County Sheriff's Cmdr. Lisa Nash. The employee then saw Pieper and another man, Corey O'Halloran, trying to shove the bottle into a backpack.

"They noticed the employee and split up," Nash said. When the manager confronted O'Halloran and looked in his backpack, he found nothing, so he turned to go after Pieper.

But O'Halloran walked in front of him and then proceeded push and shove the manager, and punched him in the chest, Nash said. The victim later told deputies it seemed like O'Halloran was attempting to delay him so Pieper could flee — which he did.

Spanish Bay employees got into a golf cart to try to find the suspected gin thief, but O'Halloran blocked their way.

The employees grabbed O'Halloran and held him down until deputies arrived, Nash said. "He was trying to swing as they were holding him, but he didn't hit anyone."

The arresting deputy, Benjamin Payton, discovered O'Halloran was on probation for trespassing on Pebble Beach property, she said.

O'Halloran told deputies, "he knew he wasn't supposed to be there, he was taking a shortcut home and didn't realize he was on their property, he didn't know anything about someone stealing a bottle of gin, and he was standing there minding his own business and they tackled him," she said.

Although Pieper had fled, the deputy took a cell phone from O'Halloran, who received a call from his alleged accomplice, and with the help of Pacific Grove Police Department, sheriff's deputies identified Pieper, tracked him down and arrested him in Pacific Grove the next day, according to Nash.

The manager O'Halloran is accused of assaulting was not injured.

'Best Buddies' tackle road again

THE BEST Buddies Challenge — which supports people with intellectual or developmental disabilities — returns Saturday to Carmel Valley, Carmel and Big Sur.

More than 1,200 riders will take to the pavement Saturday, likely causing minor traffic delays throughout the morning.

In Big Sur, riders begin their treks at three locations along Highway 1 — the Big Sur

ranger station just north of the Pfeiffer Big Sur State Park entrance, Sand Dollar Beach and Ragged Point.

In an effort to ensure a safe event, California Highway Patrol will monitor the race while American Medical Response will provide ambulance service. In 2007, two riders were airlifted to hospitals after suffering injuries while participating in the race.

Scheduled to attend the event are honorary co-chairs Maria Shriver and California Lieutenant Governor Gavin Newsom, Olympic gold-medalist Carl Lewis, Sacramento mayor and a host of entertainers and dignitaries.

The event will feature 100-mile, 62-mile, 30-mile and 15-mile bicycle routes, as well as a 5K run and a 3K walk. It will conclude in San Simeon with a BBQ and concert by Smash Mouth.

Preceding Saturday's festivities will be a golf "challenge" and reception hosted by Shriver at Tehama Golf Club.

Wounded stranger was victim in mysterious rollover crash

AN INJURED man who wandered up to house on Carmel Valley Road last Tuesday morning asking for help was apparently thrown from his Ford Explorer when he rolled it. But Samuel Jackson, 42, who awakened in a field after the crash, didn't remember it at all, according to California Highway Patrol public information officer Bob Lehman, so officers used physical evidence to determine what happened.

Monterey County Sheriff's deputies initially took the call when, shortly before 6 a.m. Aug. 30, Jackson knocked on the door of a Carmel Valley Road residence asking for an ambulance. Without letting the stranger inside, the occupant dialed 911, and paramedics took the man to Community Hospital of the Monterey Peninsula.

Monterey County Sheriff's Cmdr. Lisa Nash said medical staff initially thought Jackson — whom Lehman said suffered multiple lacerations to his head, face and upper torso, as well as bruises on both arms — had been assaulted, so a deputy was summoned to question him.

"He remembered waking up in a field and going to the nearest house," Nash said. Jackson reportedly told the deputy he had been driving with a friend.

"He didn't have much on the guy he was supposedly out with," she said.

With little information, deputies went in search of the accident site and found the crushed red 1997 Ford Explorer in a stand of trees off of Carmel Valley Road near Loma del Rey.

"There was extensive front-end damage,

and it appeared the vehicle had flipped on its driver's side" and then tumbled several times, Nash said, adding that the Explorer's hood and other contents were found in the trees, which were also damaged. "The keys were still in the car."

According to the CHP, which took over the investigation, the SUV rolled several times after Jackson drifted to the left and then overcorrected, losing control of the SUV, which came to rest off the south side of the road in the trees.

"It appears the driver was ejected from the vehicle," Lehman said, as he wasn't wearing his seat belt.

"It's pretty obvious," he added. "In a rollover, you can tell when the seat belt was used."

CHP officers also concluded Jackson was the sole occupant, even though he had said he was with a friend.

"It didn't appear that there was anyone else in the vehicle at the time of the crash," he said. "And there were no witnesses."

Officers won't be able to determine whether Jackson, who is the registered owner of the Explorer and is listed as living in Salinas, but who told the cops he lives in Carmel Valley, was drunk or on drugs when he wrecked.

"It's unknown if he was impaired at the time of the crash, because we don't know what time the crash happened," said Lehman, who also remarked that it's unusual for someone to walk away from such a violent accident.

"Especially when they're ejected, you don't see this kind of outcome very often," he said.

Point Lobos Ranch plan inches forward, aerial trail to be considered

A THREE-YEAR planning process to open Point Lobos Ranch to the public is now under way — and will determine whether it's a good idea to permit a zip-line trail to operate in the park.

Three weeks ago, The Pine Cone reported California State Parks was considering a proposal to allow a concessionaire to operate an aerial trail in the park. Utilizing a zip-line, which consists of a pulley suspended on a cable, an aerial trail allows people to use gravity to travel across a landscape — often hundreds of feet above the ground.

State parks official Dana Jones defended the proposal, observing that such an activity has less impact on the environment than even a hiking trail. And because the proposal has so few impacts, Jones initially suggested it could be implemented without going through the rigorous general plan process.

Jones estimated an aerial hiking trip will cost \$80 to \$100 a person — and she suggested State Parks needs to consider such revenue-enhancing ideas to offset its budget crisis.

But one-time Point Lobos State Reserve

park aide Joyce Olcese said she was worried about allowing such an activity and she urged Jones and other state park officials to consider the aerial trail proposal within the park's general plan process. And while the Point Lobos Foundation isn't taking a stand for or against the aerial trail, its board of directors also asked park officials to examine the proposal when the general plan is considered.

The 1,300-acre ranch has never been open to the public since it was acquired for \$13 million in a series of transactions ending in 2006, in large part because cash-strapped State Parks hasn't been able to afford the cost of completing a general plan, which is required before a trail system can be constructed.

But Jones, who recently replaced Mat Fuzie as the head of the Monterey Ranger District, said the planning process has now officially begun — and the consideration of the aerial trail proposal will be examined as part of it. AECOM, an engineering and architectural design firm, has been hired to facilitate the process.

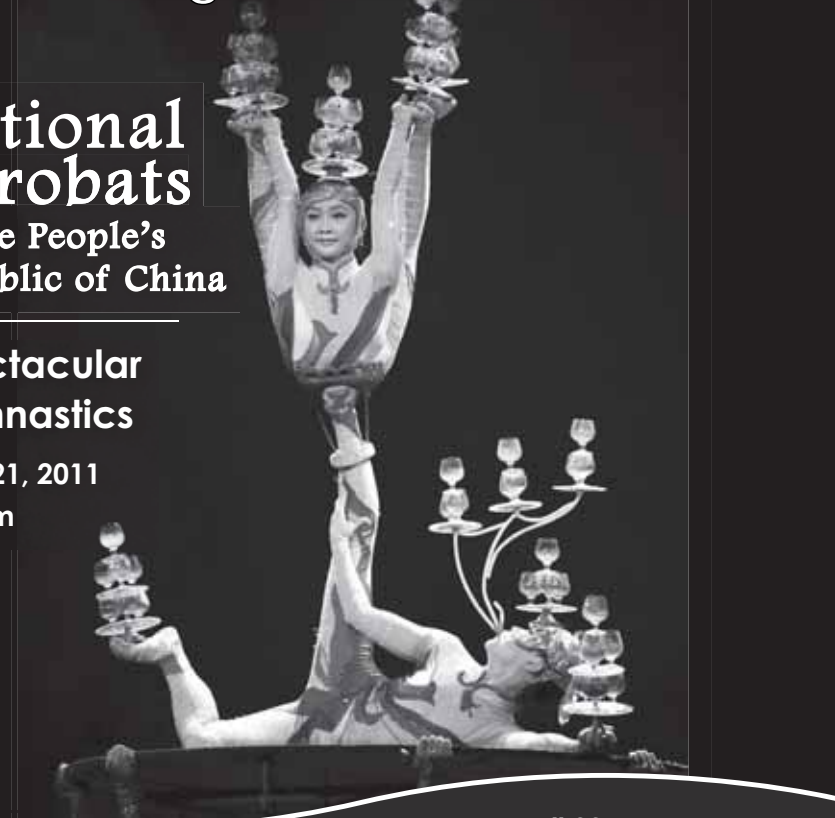

offering police protection. Is there an assassination plot that I am not aware of? They said my friend Secretary of Defense Leon Panetta sent them as a practical joke!"

A campaign video available on YouTube compares Pepe to Indiana Jones and features photos of him posing with exotic cars, beautiful women and VIPs.

If he can find a home in Carmel-by-the-Sea, Pèpe said his platform in the mayor's race would include a daytime ban on fog.

He would also have Carmel recognized as a green city. "We are almost there anyway, and only someone needs to fill out paperwork to get us accredited," he commented.

Pèpe said the city has to address parking issues, and he would do so by drawing from his experiences in his New Jersey hometown.

"In my town of Hoboken, they have the worst parking situation imaginable," he said. "Now they have created one-way streets and diagonal parking on a lot of the streets. They created 25 percent more parking and a much better flow. I would make a big move on fixing the parking problem, which is also a detractor for residents and visitors to come downtown."

In addition, he would promote resident-serving businesses. "That may be easier said than done, but we need to try," he said. "We are down to one pharmacy and one small hardware shop, and I can't think of more than one men's barber shop." Not that he needs one.

He also opposes writing more laws and imposing new fees. "We have plenty of rules as it is. The administration spends too much time and money creating new rules on top of rules," he commented. "Let's spend time doing more creative things. We are one of the most codified cities in California already."

Having run businesses in Carmel for years, Pèpe is already well acquainted with the city's rules and has occasionally attracted the attention of officials who criticized him for not following them. Prior accusations included serving wine and hors d'oeuvres to patrons on the sidewalk as they waited for tables at Little Napoli, and operating VINO Napoli more like a wine bar and less like a tasting room.

"Anyway, that's a start," he said of his to-do list.

With the election seven months away, Pèpe has time to find a home in town and collect enough signatures from registered voters in late December and early January to become a candidate.

Later, Brodzki's wife convinced Price to take a 10-hour train ride to Warsaw in the middle of winter to try out for a television role that "needed an American voice."

In Warsaw, Price auditioned for the part. "I thought I was horrible," he recalled. "Then they did a closed door meeting. After a while, the casting director came out and said, 'Everybody thought you were perfect.' Nobody believed I hadn't acted before."

For one episode in the popular Polish television series, "Traz albo Nigdy!" — which translates into "Now or Never!" — Price plays the departed lover of Agata Buzek, one of Poland's most famous actresses. Buzek's father, by the way, is Jerzy Buzek, who is head of the European Parliament.

According to Price, the role in the television series "got me a lot more attention than I probably deserved."

"It's a prime time series that's highly rated," he explained. "Agata is a household name in Poland. In America, this would be like me playing Angelina Jolie's husband."

Whether he deserved the attention or not, Price's cameo landed him a chance to join the cast of "Essential Killing." Skolimowski was no doubt impressed by the American actor. Price auditioned three times, each time for a more important role in the film. He was eventually hired to play the part of the American interrogator.

In his brief role in the film — which lasts about a minute — he questions Gallo's character, Mohammed, who has been captured by American troops.

On the set of "Essential Killing," Price didn't have to worry about precisely following a script. That's because he didn't have one. "[Skolimowski] has a method of working that's pretty unusual. He's looking for a natural reaction."

To enhance the realism of the scene, Price never saw the prisoner's face until the camera was rolling and a guard pulled a hood off his head.

Immersing himself in the characters he is portraying, Price has discovered that acting is nothing like what he imagined it to be.

"I once had the naive view that acting was just pretending," he explained. "Then I had the revelation that I'm not pretending to be this person, I *am* this person."

Meanwhile, Price has used his ability to access and understand his emotions — which was no doubt fine-tuned by years of group process work at Esalen — to enhance his skills as an actor. "Esalen wound up being a better acting school than I anticipated," he laughed.

"Essential Killing" has received an impressive 83 percent rating from Rotten

Tomatoes. Filmmaker Quentin Tarantino and actor Jack Nicholson called it their favorite film of 2010.

Lester named coastal commission chief

THE CALIFORNIA Coastal Commission has appointed a 14-year employee as the new executive director of the powerful agency that regulates development along the coast.

On Sept. 8, the commission unanimously chose Charles Lester to replace longtime director Peter Douglas, who announced his resignation from the position in early August. Lester, who has been senior deputy director of the commission since 2006, had been acting executive director since Douglas' retirement.

"The entire commission recognized and appreciates the unique experience, unwaver-

ing integrity, and clear vision Dr. Lester brings to this position," Commission Chair Mary Shallenberger said in a prepared statement. "While Peter Douglas leaves very large shoes to fill, Charles fits into them quite comfortably."

Lester received his Ph.D in Jurisprudence and Social Policy from the University of California at Berkeley. In addition, he earned his J.D. at Boalt Hall School of Law and a B.A. in Geochemistry from Columbia University, according to the commission.

Lester oversees an agency with 142 authorized staff positions and an annual budget of approximately \$16 million.

Roxana Holmes Blanks

claimed a tax benefit called the Additional Child Tax Credit, which is intended for families who are U.S. citizens.

The audit found that in 2010, 2.3 million illegal immigrants filed for the tax credit, costing taxpayers about \$4.2 billion. That number was the highest in five years, having skyrocketed four-fold from 2005, when the amount claimed was \$924 million, the audit found.

An earlier study by Public Policy Institute of California showed that 1 in 7 residents of Monterey County is an illegal immigrant — the highest percentage of any county in the state.

“Although the law prohibits aliens residing without authorization in the United States from receiving most federal public benefits,” according to the Treasury Department report, “an increasing number of these individuals are filing tax returns claiming the Additional Child Tax Credit, a refundable tax credit intended for working families.”

The tax credit, which is based on earned income, apparently offers a good reason for illegal immigrants to come to the United States — and stay here, the report found.

“The payment of federal funds through this tax benefit appears to provide an additional incentive for aliens to enter, reside and work in the United States without authorization, which contradicts federal law and policy to remove such incentives,” according to the Treasury Inspector General.

The audit was conducted to determine whether potentially fraudulent tax returns filed with an Individual Taxpayer Identification Number — a nine-digit number the IRS gives to those ineligible for Social Security Numbers — “were being properly and consistently worked,” according to the Treasury Inspector General. Because of the high volume of returns filed by those with ITINs claiming the child tax credit, the audit focused on those returns.

While ITINs allow illegal immigrants and others who don’t have a SSN to work and file taxes, it doesn’t permit them to claim federal benefits, such as the child tax credit. But in 2010, 2.3 million ITIN filers did just that, racking up the \$4.2 billion bill.

With the exception of certain emergency services and programs, the law prohibits illegal immigrants from receiving federal benefits. Therefore, illegal immigrants and others with ITIN numbers who claim child tax credits are erroneously doing so.

The average dollar amount claimed by those with ITIN numbers per single return for the tax credit in 2010 was about \$1,800. However, the report also noted that nearly 9,000 taxpayers each claimed a total of \$10,000 or more by filing multiple tax periods. Some individuals even submitted duplicate tax returns for multiple years to multiple IRS processing cen-

ters to receive the refunds, according to the report.

In 2010, for example, about 238,000 people with ITIN numbers filed more than 608,000 tax returns for multiple years at the same time and claimed just more than \$1 billion dollars in the credit on those returns.

Billions go unchecked

And this is not the first time the federal government has identified major abuse of federal benefits. In 1996, after concerns were raised by Congress, the Government Accountability Office and the IRS over Earned Income Tax Credit given to those without Social Security Numbers, the government passed a law prohibiting those with ITIN numbers from receiving the federal benefit.

And even though the law was passed before the establishment of the Additional Child Tax Credit, the IRS continues to pay out the credits to illegal immigrants.

“Nonetheless, IRS management’s view is that the law does not provide sufficient legal authority for the IRS to disallow the Additional Child Tax Credit to ITIN filers,” the report said.

IRS spokeswoman Michelle Eldridge in statement to the press said the IRS is only doing what the law permits.

“Any suggestion that the IRS shouldn’t be paying out these credits under current law to ITIN holders is simply incorrect,” Eldridge said. “The IRS administers the law impartially and applies it as it is written. If the law were changed, the IRS would change its programs accordingly.”

Recommendations to the IRS

The report recommended the IRS work with the Department of Treasury to “seek clarification” on whether or not refundable tax credits may be paid to those not allowed to work in the country.

It also said the IRS should require those filing with ITINs and claiming the tax credit to verify that their dependents meet the qualifications for the credit, including residency.

Though the IRS created the ITIN to help those who cannot obtain a Social Security Number comply with U.S. tax laws, in order to get a job, those who carry ITINs may “fabricate an SSN or improperly use someone else’s SSN (and sometimes their name) to obtain employment,” according to the report.

To stop identity theft committed by those with ITIN’s, the report recommended the IRS notify taxpayers when their SSNs are compromised, something the IRS does not do.

Though the IRS agreed to discuss with the Department of Treasury the issue of eligibility among ITIN filers, it did not agree to require additional documentation to support child tax credit claims on ITIN returns, according to the report.

In 2010, the Treasury Inspector General determined that 14 percent of non-ITIN filers, or those with Social Security Numbers, claimed the additional child tax credit, while 72 percent of those with ITINs, claimed the federal benefit.

On Sept. 2, U.S. Senator Orrin Hatch, ranking member of the Senate Finance Committee, said he would examine the refundable tax credits. He called the findings “disconcerting” and said the report demanded immediate attention from Congress and President Barack Obama.


“With our debt standing at over \$14.5 trillion and counting,” according to Hatch in a statement on his website, “it’s outrageous that the IRS is handing out refundable tax credits ... to those who aren’t even eligible to work in this country.”

Brett turns 100 — Weston Gallery offers retrospective

TO CELEBRATE the 100th anniversary of his birth, the Weston Gallery unveils an exhibit Saturday, Sept. 10, that pays tribute to the creative legacy of fine art photographer Brett Weston.

The photographer, who died in 1993, was the son of Edward Weston and the brother of Cole Weston. The elder Weston ranks among the most influential of all fine art photographers, while the latter also left behind an impressive body of work.

Born in Los Angeles in 1911, Brett's career as a fine art photographer began when he was just 15.

"His father pulled him out of school, took him to Mexico and gave him a camera," explained Richard Gadd, the director of the Weston Gallery.

Two years later, Brett staged his first exhibit (in Germany), and by the time he was 21, he was offered a one-man retrospective at the De Young Museum in San Francisco. Van Deren Coke, the curator of the San Francisco Museum of Art, was so impressed with Brett's work that he called him, "the child genius of American photography."

Over the next seven decades, Brett established himself as a creative visionary in his genre. Like his father — and unlike his brother — he exclusively shot his work in black and white.

"His photographs tended to be more abstract than Edward's," Gadd observed. "He was very deliberate in his composition [in an effort to] create abstract forms and shapes."

In addition to his own work, Brett helped his father print his work, particularly in his later years when Edward was suffering from Parkinson's Disease.

The exhibit at the Weston Gallery will feature more than 50 of Brett's images, ranging from about 1930 to the mid-1980s. The show aims to illuminate the work of a remarkable artist who was once a familiar face in the Carmel area. "He

Temptations return to Sunset Center, Moonalice pays tribute to Summer of Love

PERHAPS THE most enduring of all Motown acts from the record company's heyday in the '60s and early '70s, the Temptations return to Sunset Center Thursday, Sept. 15.

From their first No. 1 hit, "My Girl," in 1965, to their last chart-topping record, "Papa Was A Rolling Stone," in 1972, the Temptations' music reflected the dramatic changes of the times.

Best known for their sweet harmonies and slick stage moves, the Temptations could make irresistible dance music ("Ain't Too Proud To Beg," "Get Ready"), sing soft and sensitive ballads ("Just My Imagination") and produce thought-provoking social commentary ("Ball of Confusion").

The last living member of the Temptations' classic mid-1960s lineup, Otis Williams leads the present incarnation of the group. He'll be joined at Sunset Center by Ron Tyson,

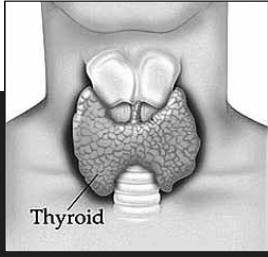

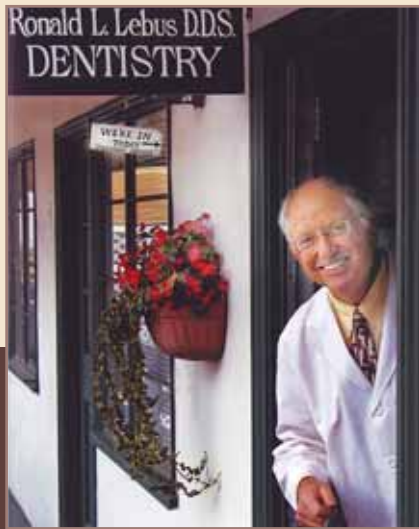

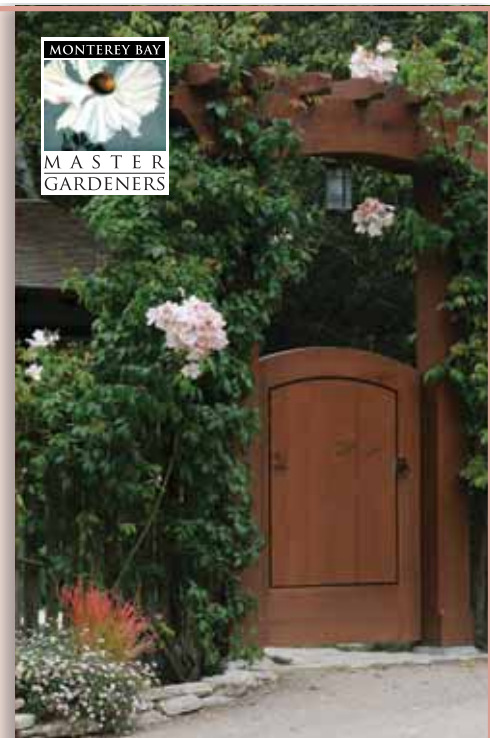

calm and cooperative, always trying to make it a win/win," Lewis remembered.

He was also known for his philanthropical efforts and charitable work, participating on numerous boards. Murder mystery a reminder how little town has changed

WHILE KATHRYN Gualtieri's Carmel-based mystery novel, "Murder in the Pines," is set in 1921, its reoccurring themes — a land use battle between developers and environmentalists, contentious city hall meetings, charges of sexism and a debate over whether to modernize the town — bear a striking resemblance to the political topics that are being discussed in 2011.

"The same issues still exist today," observed Gualtieri, who splits her time between Capitola and Carmel. The author will sign copies of the book Saturday, Sept. 10, at River House Books. The event begins at 3 p.m.

A controversial proposal to build a hotel on Carmel's beach and a young woman's journalistic aspirations — she works for The Carmel Pine Cone — lie at the heart of "Murder in the Pines." Gualtieri, by the way, worked for The Pine Cone as a freelance writer during the 1990s.

While the characters in Gualtieri's book debate what's best for Carmel, the plot thickens when two prominent citizens turn up dead.

"It's a fictional story that's meant to be entertaining," Gualtieri explained. "I tried to put some history in the mix and capture the flavor of Carmel."

A host of historical figures make cameos in the story, including poet Robinson Jeffers, Mayor Perry Newberry, architect Julia Morgan and artist Mary DeNeale Morgan. Some of the area's most notable landmarks are featured in the book, including La Playa Hotel, the Pine Inn and Carmel's famous beach.

The book also touches on many of the quirky charms of living in early Carmel — residents, for instance, use hand-made tin-can "candle lamps" when they walk through the village at night.

COUNCIL POISED TO APPROVE CONTRACT FOR NEW CITY ADMINISTRATOR

By MARY SCHLEY

THE CARMEL City Council will consider signing a three-year contract with incoming city administrator Jason Stilwell when it meets Sept. 13. Stilwell, the assistant county executive officer for Santa Barbara,

is set to receive \$176,500 in annual pay for his work heading the city, plus benefits, an automobile allowance and \$15,000 to move here.

According to the contract, his first day of work will be Sept. 28. He is replacing former city administrator Rich Guillen, who retired

in March following the \$600,000 settlement of a sexual harassment lawsuit. A temporary city administrator, John Goss, has been running the city since April.

Stilwell's resume describes him as an, "innovative, dedicated public servant, strategic thinker and visionary with a 20-year history of promoting excellence and best-in-class performance in county, town and city management." He also said he ended every year at or better than projections and listed his skills as "resource allocation, expense control, HR management, talent acquisition, process improvement, staff development,

strategic planning, change management, community and intergovernmental relations, disaster and emergency management, financial and growth management, economic development and media relations."

The council chose Stilwell out of a field of 128 applicants that was whittled down to 20, and then to just over half a dozen, by recruiter Bobbi Peckham of Peckham & McKenney. Most of the finalists were from California. City staff, the heads of all the commissions, and a group of community

Editorial

Changing times

THE STORY is getting so familiar, it's practically a fable. But like any worthwhile old saw, the tale of Monterey County's shifting political center is relevant to many things and keeps popping up in new controversies.

By now, you're surely familiar with the basics: The Monterey Peninsula is wealthy, but its no-growth policies have worked so well over the last 20 years, its population has stagnated or even shrunk. Meanwhile, in the Salinas Valley, where many families are struggling with low incomes, the population has boomed.

The result is that the center of political influence in Monterey County has ineluctably moved to the east. And as they've become more confident about their growing power, Salinas Valley elected officials and community advocates have become more and more impatient with what they see as the Peninsula's "whining" and have increased their demands that its residents quit being so self-centered.

The trend was on full display during a Monterey County Planning Commission hearing last week on the proposal to build 46 upscale condos on the site of the former Carmel Convalescent Hospital, which is just outside the Carmel-by-the-Sea city limits in the county's jurisdiction.

From the point of view of planning commissioners from Salinas or Soledad, this project is a low-density paradise that anyone would be proud to call home, and which they would surely love to have built in their towns. But to the people who live in the single-family neighborhood around the 3.68-acre hospital site, it's an urban abomination that would ruin their lives.

For example, while residents said the condo project would cause nightmarish traffic congestion, a planning commissioner from North County said, "What traffic?"

And another commissioner responded to comments from Carmel residents calling the condo project "massive" and a "blight," by describing it as "classic infill" — a concept which is supposed to be the Holy Grail of modern planning.

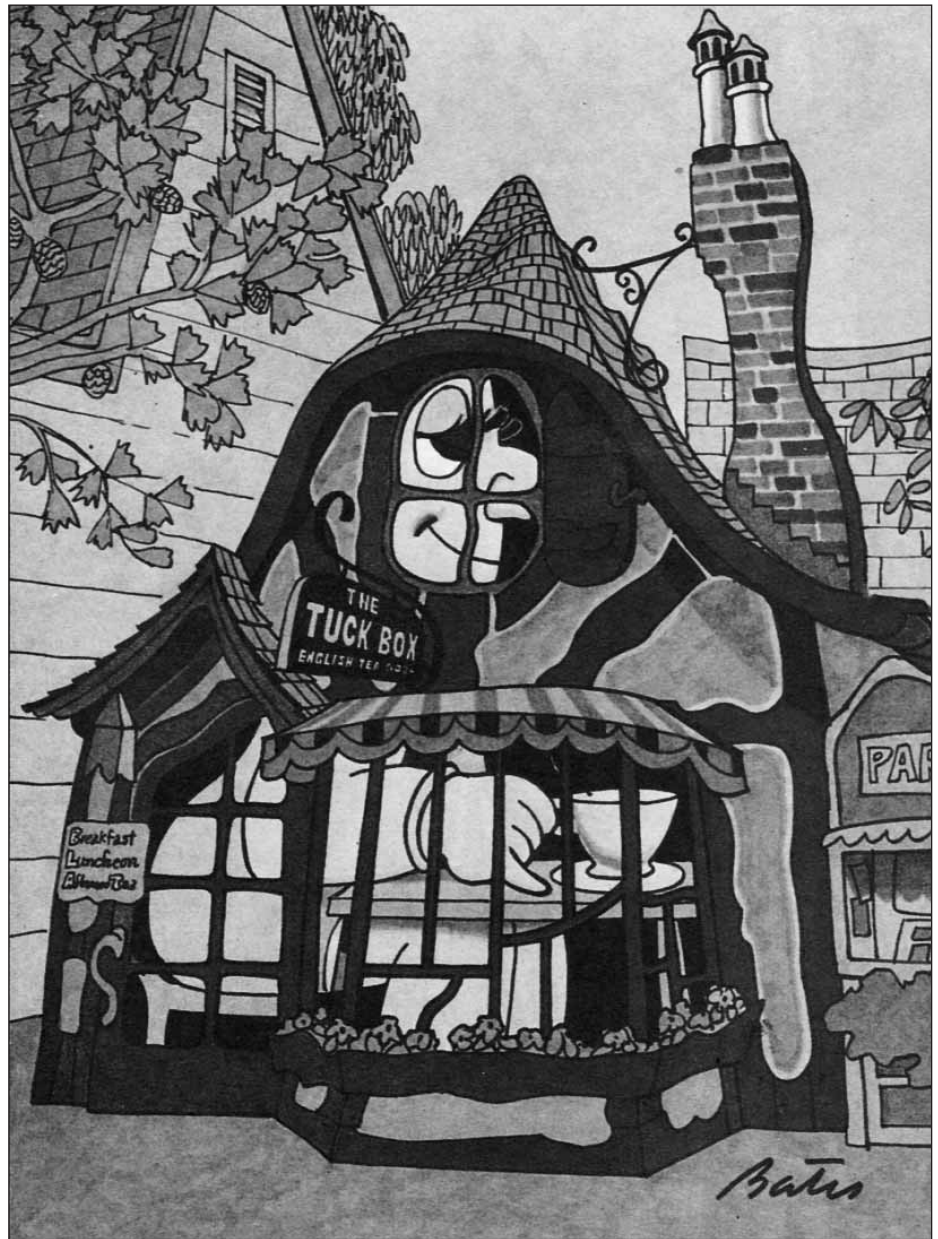
Who's right? They all are, of course. But the point is — as was demonstrated when the planning commission voted 6-4 to approve the condo plan, with all the commissioners representing the Monterey Peninsula voting, "No" — that the Salinas Valley point of view is getting more powerful and will soon win every time.

Peninsula residents still have the all-powerful CEQA to fall back on, which means most development projects approved in the unincorporated parts of the county can still be stopped with a fairly simple legal strategy.

But the days of CEQA as the ultimate trump card are also numbered.

The economy is foundering now but will boom again before too long. And with the political balance of power permanently shifting not only in Monterey County, but in the whole state, residents of some communities may soon be wistfully remembering the days when 46 condos seemed like a lot.

It will cost an estimated \$500,000 to \$600,000 to complete the park's general plan, Jones explained. The Point Lobos Foundation has agreed to contribute \$250,000.

Jones said the public will have an opportunity to comment on any uses of the new park in about a year, when State Parks hosts a series of hearings on the subject.

"We want the public's input," Jones said. "We want the public to be involved."

Fuzie, the former head of the Monterey Ranger District, is now Northern Division chief of State Parks and will split his time between Monterey and Sacramento. The Monterey Ranger District encompasses all of Monterey County, as well as parts of San Benito, Stanislaus and Santa Clara counties.

Herrera "was induced to move from Palm Desert to accept this position, based on the defendants' promises that she would average approximately \$1,000,000 in sales per year," according to the suit. Herrera "believes ... that no retail sales professional came close to reaching this level of promised sales."

In July 2009, when Herrera said she applied for a promotion to the operations manager position, she claims store manager Amanda Thompson denied her the job because "English was not her first language."

"Thompson informed Herrera that they were reserving the position for someone with 'perfect English and grammar,'" according to Herrera's suit, filed for Herrera by San Francisco attorneys Dustin Collier and Stephen R. Jaffe.

However, the lawsuit also alleges that prior to applying for the promotion, Herrera received numerous commendations, positive performance evaluations and other accolades from her superiors.

A month after being turned down for the promotion, Herrera claims her immediate supervisor, Sarah Knutson, began a "campaign of discrimination, harassment and retaliation against Herrera on account of her race, ethnicity, national origin and religion," the lawsuit alleges.

Herrera alleges Knutson frequently referred to her as "brownie" and "beaner," referring to Herrera's Mexican heritage. She also alleges Knutson made fun of her accent and grammar. She claims "caucasian" employees were treated differently.

Besides making fun of the way she spoke, Knutson would direct customers to other sales agents to reduce her overall sales and therefore commission, Herrera claims. She also alleges Knutson gave her a variety of tasks that did not involve sales, such as setting up window displays and cleaning duties "designed to give Herrera less time to conduct the sales ... and less opportunity to make any commission income."

Herrera's lawsuit said store managers denied her meal and rest breaks, and sick and vacation leave.

"If Herrera attempted to take a lunch break during her shift," according to the suit, "Knutson would scream at her in front of coworkers, humiliating and shaming her into forgoing her legally mandated breaks."

Herrera also said she was discriminated against because of her religion. On one occasion, she claims Knutson called her a "loser" when she told Knutson she she grew up Baptist. The manager also told her she wasn't allowed to wear a religious ring given to her by the church she attended, according to the former worker.

On Feb. 25, 2010, Herrera complained to Thompson about Knutson's alleged racist comments and behavior, and her refusal to grant Herrera breaks and time off. Herrera needed the time off because "she could not take the hostile work environment any longer and felt compelled to speak up," the lawsuit says.

"Herrera was terrified to raise these complaints, knowing that Knutson and Thompson were personal friends outside the workplace," according to the suit.

On March 4, 2010, Herrera said Thompson — citing low sales figures — wrongfully fired her without giving her final compensation for unpaid overtime and missed breaks, the former employee contends.

"Herrera's race, ethnicity, national origin and religion also formed a substantial motivating factor in the defendants' decision to retaliate against her and ultimately discharge her," Herrera claims in the suit.

Herrera denies not meeting meet the store's sales expectations and instead blames the low numbers on actions by her supervisors.

"For example, the drop in sales was a direct result of Knutson's efforts to distract Herrera from selling merchandise with non-sales duties," Herrera claims.

The lawsuit also alleges the store had a practice of what Herrera's suit calls unlawful "chargebacks."

"In particular, if Herrera earned a commission on a sale, the defendants would track whether the item was later returned, and would deduct the value of the commissions on such returned items" from her commission, according to the claim. Because Herrera didn't agree to the chargebacks, they were illegal, the suit claims.

bad if they are released back into the wild, the SPCA tries to let Momma teach the owls as much as possible with minimal interference from people.

"She does a great job even with the one wing," Brookhouser said. "I would say Momma has a personality that handles confinement well, and she seems to enjoy her volunteer work at the SPCA."

Baby owl No. 1, found on River Road in Salinas, was a "brancher" when he was rescued — meaning the bird was living mostly out of the nest but was still unable to fly.

"Unfortunately we were unable to re-nest the baby owl with its parents, as we could not get access to the property," Brookhouser said. "The owl was a little dehydrated but otherwise healthy."

Baby owl No. 2, an older nestling who was on the verge of becoming a brancher, was found in South Monterey County. "The baby owl was very dehydrated and suffering from a serious eye infection," Brookhouser said. "It needed to be rescued in order to survive. It is now doing very well."

Lighthouse volunteers meet in Monterey

THE PRESERVATION and restoration of historical lighthouses will be the subject of a two-day conference that begins Monday, Sept. 12 at the Museum of Monterey.

The Central Coast Lighthouse Restoration Conference is co-sponsored by the nonprofit Central Coast Lighthouse Keepers. Among the subjects that will be discussed during the conference will be the continued preservation and restoration of the landmark light station at Point Sur State Historic Park. At Point Sur, more than 80 volunteers — all of whom are members of the CCLK — perform most of the tasks associated with running the park. While some lead tours, others work to maintain and restore the light station.

Baby owl No. 3 was found in the middle of a walking trail off of Spruance Road in Pebble Beach.

"We were unable to locate its parents," Brookhouser said. "The nestling was dehydrated and showed signs of mild head trauma, but recovered after two weeks."

Being a mommy to baby birds is tiring. "Momma seems to be happy when they are gone," Brookhouser said. "But she is always happy to raise a new group of young ones."

Though Momma isn't mobile enough to kill live mice because she only has one wing, she teaches the babies how to climb, eat and generally act like wild owls. "With Momma, it's just nice to have somebody who looks like them instead of humans," said wildlife supervisor Rosanna Leighton.

Momma eats dead mice that have been frozen and then thawed. Now that the rescued baby owls are older, they're given live mice, which they kill on their own without any direction. "It's very much instinctual," Leighton said.

The birds will be ceremoniously released as part of the SPCA's 18th Annual Wild Celebration fundraiser on Sunday, Oct. 2, at Holman Ranch in Carmel Valley from 2 to 5:30 p.m.

forego an 8.75 percent salary increase due last January under the terms of a [labor contract] which has now expired," Goss continued. "The savings of foregoing this raise is \$70,000 calculated through Aug. 15."

Overall, however, Cal Fire would cost less in the near term, according to the report. A contract with Monterey this year would have saved \$148,771, while contracting with Cal Fire would have reduced expenses by \$275,875, compared with the costs of running a stand-alone department. From 2012/2013 to 2015/2016, the cost differences between a contract with Cal Fire and a merger with Monterey would be \$147,458 to \$202,959.

He cited greater potential "for future cooperation and shared services with Pacific Grove and Monterey," and the opportunity to save \$400,000 by taking advantage of MFD's equipment instead of having to purchase a new engine to replace the 23-year-old reserve engine in the CFD fleet.

Goss recommended against signing a contract with Cal Fire, saying such an agreement's long-term costs would be uncertain because of retirement pay. More importantly, if Carmel's firefighters became part of a state agency, they might be sent to fight fires anywhere in California.

Goss recommended the city keep an engine at the Carmel station staffed by three firefighters 24/7, and it should continue to own the building and equipment.

"If the city council accepts these recommendations, staff will work with Monterey and the city attorney to develop an agreement for review and possible adoption at the council's October meeting," Goss concluded. He said the Monterey contract could be amended to call for a full merger, developed with input from the firefighters' union.

The council is set to meet at 4:30 p.m. Tuesday, Sept. 13, in city hall on Monte Verde Street south of Ocean Avenue. For information or a copy of the fire services report, call (831) 620-2000.

The event supports the SPCA rescue and rehabilitation center, which is the only full-service wildlife rescue center in Monterey County. The organization does not receive funding from any federal, state or local government agency.

members — including representatives of the Carmel Residents Association, the Red Cross, the Carmel Public Library Foundation, The Carmel Foundation and other groups — also helped in the selection process.

The contract set for authorization Tuesday includes \$176,500 in salary, a \$350-per-month automobile allowance, and medical and other benefits. In a separate item on the agenda, council members will be asked to consider spending \$15,000 on Stilwell's relocation from Santa Barbara to Carmel. The money will cover "the packing and shipping of the family's household belongings, temporary housing for the family as they transition to permanent housing, and house-hunting expenses and all incidentals."

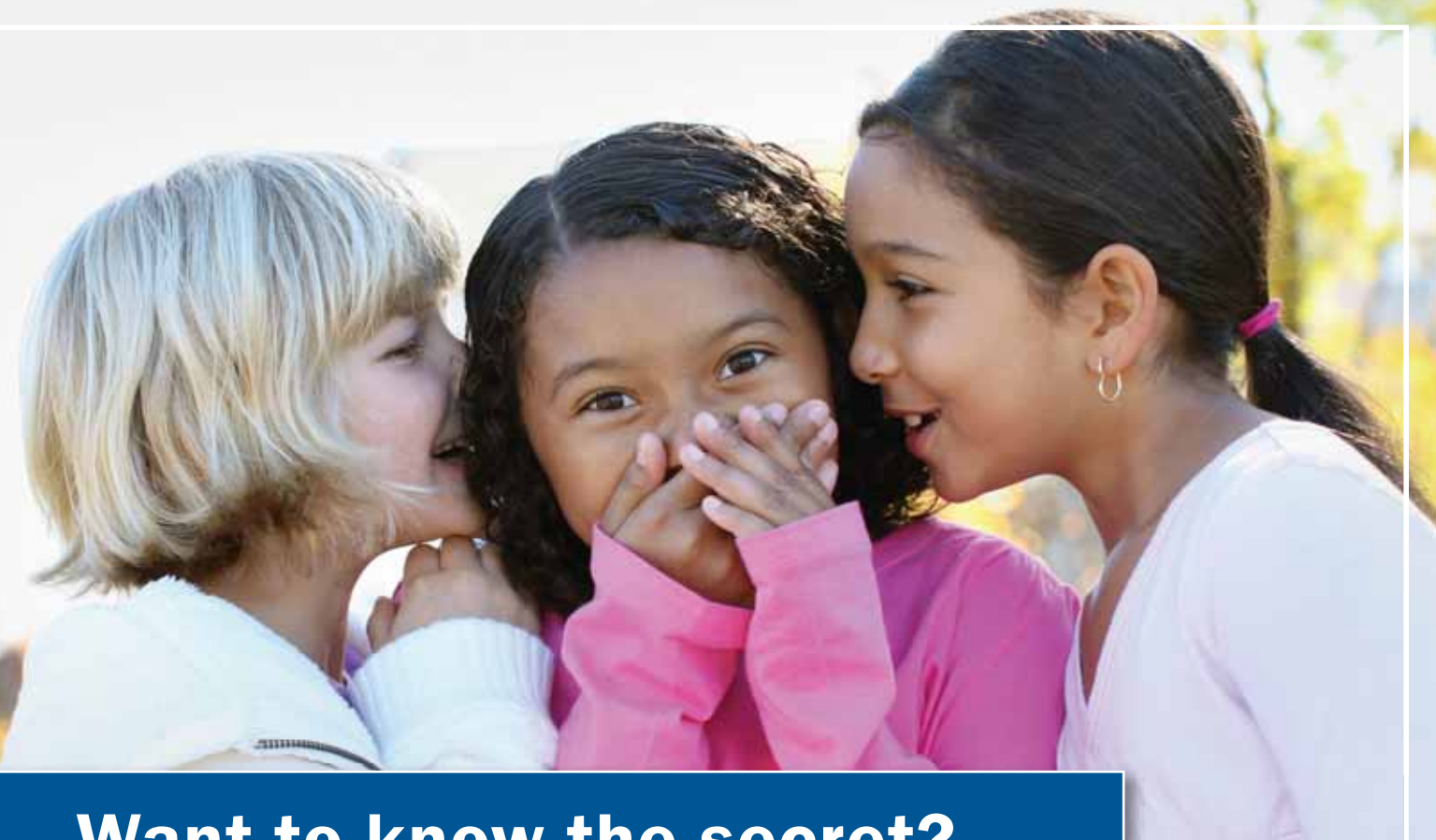

If you didn't know it was there, you might easily pass by the GREAT WALL OF CARMEL. It's a Carmel stone monument, 2-1/2 feet wide and slightly higher than a man's head, that completely encloses an entire block. 4th and 5th Avenues are on north and south, Guadalupe on the east, Santa Rita on the west. All along the top of the wall are jagged stones set on an edge, a distressingly sadistic touch. The wall dates from 1925, when a man named Smith (from Southern California) caused it to be built by two stone masons who spent three years on the project. He planned a major estate on the property, but went no further than a caretaker's cottage, elaborate walks, patios, pools, and a giant BBQ pit before his interests led him to a farm in the lower Carmel Valley and his block was sold.

He headed back south, and today there are many small lots and private homes inside the enclosure. A few gateways have been broken through, and here and there a growing pine tree is winning the war of the wall. Start at Guadalupe and 4th where you'll find the main gate, a forbidding iron structure with the initial "S" set in small stones beside it, then walk around this interesting block... you'll enjoy it. You might even hear the hoof beats of the horse who haunts the great wall!

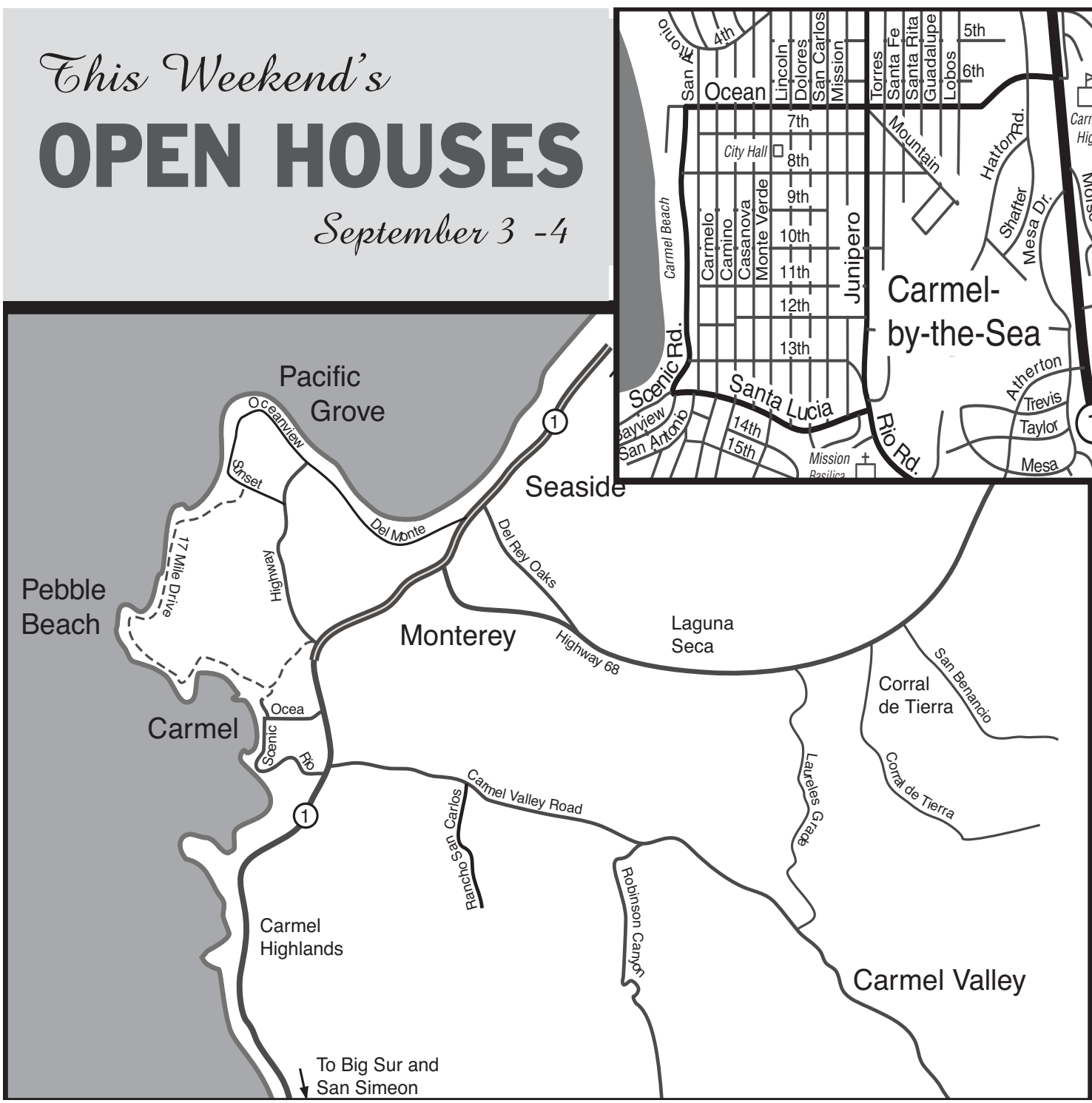
