Salyer gets six years in federal prison

Expresses remorse, but victim doubts it

SACRAMENTO — PEBBLE BEACH businessman Scott Salyer, who once presided over one of California's most successful agricultural firms, was sentenced to six years in federal prison Tuesday by U.S. District Judge Lawrence Karlton for racketeering, bribery and pricefixing in a case that has also seen several of Salyer's former top lieutenants put behind bars.

He also agreed to forfeit more than \$3 million stashed in a bank account in Andorra, but he escaped millions more in fines sought by prosecutors because the formerly wealthy Salyer, 57, who enjoyed a lavish lifestyle and lived in a mansion near the Lodge, is now broke, according to Karlton.

"There's no money to pay a fine with," the judge said during a dramatic sentencing hearing in a packed 15th floor courtroom.

Pressed by prosecutors, Karlton conceded that Salver may receive a portion of the nearly \$50 million in proceeds from the recent sale of Cedenco, his successful tomato processing business in Australia.

But he accepted the defense argument that Salyer is already facing \$163 million in civil judgments stemming from his criminal activity, and is likely to face a

The sentence was a compromise between the seven years sought by the prosecution team, led by Assistant U.S. Attorney Matthew Segal, and the four years Salyer's defense attorneys argued for.

After being indicted on multiple charges in February 2010 and arrested a few weeks later at New York's John F. Kennedy airport, Salyer spent seven months in jail while trying to get released on bail and aggressively asserting his innocence.

But in March 2012 he suddenly pled guilty, admitting that

Supes OK lower cap on C.V. development

RESOLVING A lawsuit that claimed the 2010 General Plan will allow too much development in Carmel Valley, the Monterey County Board of Supervisors voted unanimously Feb. 12 to amend the plan to lower the cap on new units in Carmel Valley from 266 to 190 and make other changes.

Opponents urged supervisors not to make the deal, arguing Carmel Valley's population is shrinking, and reducing the number of future units would be "discrimina-

Effort to have newspapers confiscated fails

■ 'SLUTS' jump line brings furious reaction

ON THE day a story about a controversial Carmel party appeared in last week's Pine Cone, a Monterey attorney took the unprecedented move of trying to compel a judge to order all the newspapers pulled from the racks.

On Friday, Feb. 8, Jeannette Witten — attorney for Racey Promotions and Vesuvio restaurant owner Rich Pepe — tried but failed to convince a judge that the papers should be pulled because of a story about a Feb. 7 party at Vesuvio on 6th and

The story, which centered around Carmel resident Carolyn Hardy's comments that young female models used to promote the party might be mistaken for "sluts and whores," also used the word "SLUTS" as its jump line, which was intended to help readers find the rest of the story on another page inside the newspaper.

CLARIFICATION

Last week we used the word "sluts" to guide readers to the inside continuation of a story about a local resident's objections to the city council about a party held at Vesuvio restaurant. The story included the resident's opinion that the provocatively dressed and posed models in a photo used to promote the party might be "mistaken for sluts and whores." The Pine Cone's use of the word "sluts" to help readers find the continuation of the story was a reference to the resident's quote, and not to the girls in an adjacent photo. The Pine Cone did not and would not refer to the girls as sluts.

"All I did was pick a word from the story that was catchy and memorable, which is what I always do with jumps," said Pine Cone publisher Paul Miller, who chose the story for the front page and wrote the jump line. "It wasn't a reference to the girls at all."

But, according to court documents filed by Witten, "continued distribution" of The Carmel Pine Cone with the words "SLUTS" in bold and caps over the photograph of the models and the headline that contained the words "disgusting and



The robbers, described as black men between the ages of 30 and 40, brandished a handgun and stole items out of a display case at about 11:35 a.m. Feb. 8 before fleeing out a back door of the business.

The store's owner freed himself and called police but the suspects were long gone before deputies with the Monterey County Sheriff's Office arrived on scene, according to the

The men, who wore white hard hats, orange reflective safety vests, and tan and brown colored pants, told employees they were at the shop to investigate a gas leak before robbing the high end shop.

Hesselbein's manager, Brad Johnson, did not respond to email and voicemail messages left by The Pine Cone.

The store, at 143 Crossroads Blvd., sells watches by Patek Philippe, Omega and Ebel, and jewelry by Aaron Basha, Mikimoto and J.B. Star.



FORA WARNED BY DA'S OFFICE OVER OPEN-MEETINGS VIOLATIONS

OFFICIALS WITH the Fort Ord Reuse Authority have been warned by the district attorney to stop violating California's open meeting laws.

On Monday, Monterey County District Attorney Dean Flippo announced he sent letters to each of FORA's voting members to stop violations of the Brown Act, which regulates public meetings.

The warning was sent following a meeting on Nov. 13, 2012, in which FORA discussed the formation of the "guiding principles" document. That meeting wasn't announced to the public. FORA officials continued modifications to the document via email through December, which was also in violation of state law, according to the district attorney's

In December, Pacific Grove Mayor Bill Kampe, a FORA board member, alleged the board was out of compliance with the Brown Act — which requires public agencies such as FORA to conduct meetings that are open to the public.

Though the law allows some closed meetings, those exceptions did not apply to the FORA meetings in question.

Tougher rules Jan. 1

The guiding principles document, which was rescinded by the Monterey County Board of Supervisors on Feb. 5, was intended to be an outline for the Fort Ord Base Reuse Plan. It also sought to give Monterey County, Monterey, Del Rey Oaks, Seaside and Marina votes in land-use decisions for the

former Fort Ord and would have excluded Carmel, Pacific Grove, Sand City and Salinas from making those decisions.

According to the DA's office, the FORA meeting in question was not effected to a new state law that became effective Jan. 1, 2013, which allows prosecutors to issue a cease and desist letter to agencies who violate the Brown Act up to nine months from the date of the violation.

Per the law, if an agency does not respond to the demand with a commitment to stop violating the Brown Act, prosecutors can seek civil action without showing "specific harm." The law does not apply to violations committed before its effective date and the FORA violations were not subject to it.

Grand Jury: Carmel wastewater district runs well, but needs to boost worker morale

THE AGENCY that provides wastewater service for Carmel and helps to irrigate Pebble Beach's golf courses is "run efficiently and managed effectively," but it could do better to improve employee morale, according to the results of an investigation by the Monterey County Civil Grand Jury.

Last week, the grand jury released the results of a review of the Carmel Area Wastewater District. It looked into the agency after receiving complaint letters claiming workplace discrimination, improper hiring practices and low worker

Though the grand jury was largely complimentary in its analysis of the agency, saying it is run well and its rates are competitive with other agencies, it also said the agency

should make every effort to ensure employee performance reviews are conducted every 12 months. The agency has 24

"After reviewing the employee satisfaction survey conducted in 2011," according to the report, "the CGJ finds that the lack of timely performance appraisals was undoubtedly a contributing factor to low employee satisfaction and a lack of communication between management and treatment department staff."

Making changes

CAWD general manager Barbara Buikema told The Pine Cone Monday that the district has listened to the grand jury and is making changes.

"The outstanding evaluations are now all on a schedule to be completed by February 28th — there's one scheduled every week until the end of the month," Buikema said. "And going forward, we have a system in place to make sure we don't fall behind again."

While CAWD's board of directors said it hired the most qualified candidate in Buikema in 2010, the grand jury noted the agency did not interview external candidates for the job position, something it recommended it do in the future.

For the most part, though, the jury found that CAWD appears to be "more proactively" maintaining its infrastructure than in previous years, Its rates are competitive with other districts, it has reasonable number of worker and it has sufficient cash on hand for planned and unplanned repairs.

"I believe it speaks very positively of the efforts our board and staff make towards the cost effective and efficient collection and treatment of wastewater," Buikema said.

The grand jury was positive in its assessment of the relationship between the Pebble Beach Company and CAWD, in which CAWD provides treated wastewater to irrigate Pebble Beach's seven golf courses and open space areas.

"This partnership, which began in 1992, has been beneficial to both districts," according to the report.

It also complimented the district's safety record, and noted an award it received from the California Sanitation Risk Management Authority for having the "best worker's compensation loss record in the small agency category."

The jury said CAWD should heed results from a 2011 employee survey and said that better communication between management and staff and increased cooperation between departments would help improve morale.





GRAND JURY SAYS RAMPANT VOTER FRAUD NOT OCCURRING IN COUNTY

RAMPANT VOTER fraud in Monterey County isn't occurring but ballots should be more "user friendly" and the \$4 million touchscreen voting machines that are collecting dust in the county elections department should be updated and used, according to findings by the 2012 Monterey County Civil Grand Jury.

The grand jury also determined that despite allegations that an ineligible person could easily fraudulently cast a vote, that isn't the case.

The present procedures of setting up multiple checkpoints in voter registration and validation of a voter's identity that is conducted by the elections office, according to the nearly 9-page report, "appears more than adequate to safeguard against voter fraud."

The grand jury investigated the county elections office after receiving a report that in November 2010 an absentee

ballot had been sent to a voter who was already dead, and that two ballots for the June 2012 primary election were sent to the same woman who had changed her marital status and name.

The jury also looked into the potential problem of election fraud resulting in tampering with electronic voting machines, the destruction of ballots and "egregious errors" in tabulating votes but also found that isn't a problem.

However, the grand jury did find that 13.7 percent of ballots cast by voters in the most recent election were damaged and unreadable by the optical tabulating scanner primarily because voters failed to follow voting instructions.

Because of that, county elections workers had to duplicate more than 7,000 ballots in order to "capture the voter's intent," which the jury called "costly and time consuming."

To make it easier for voters, the grand jury recommended the county start reusing dozens of touch-screen voting machines that were purchased in 2002 for \$4 million of taxpayer funds but which have been sitting idle since 2007.

"A different way of tabulating votes should also be considered," the jury said because of the problems with scanners.

City should evaluate costs

Though Carmel-by-the-Sea is the only city in the county to use a private contractor to conduct its elections, the grand jury recommended Carmel consider all costs and the level of service when making the decision on who to use for elections in the future.

The jury found that while it appears to cost Carmel less to hire a private company to conduct its elections than to use the county's elections services, "city officials did not take into account the actual costs of paid staff time for their own city clerk and staff."

On Jan. 10, Carmel Mayor Jason Burnett responded to the report.

"The council agrees that it is important to calculate both the direct and indirect costs of running a standalone election," Burnett wrote to Presiding Judge Tim Roberts. "However, in our situation, the staff involved were salaried employees and the total amount of time spent was

relatively small."

Carmel is also the only city in the county that chose not to consolidate its election with a statewide election such as a June primary or November general election. The city holds its stand-alone municipal elections in April of even-numbered years, which is more expensive than consolidating the elections, the jury said.

Burnett said the city saved \$33,000 in hiring a private company and cited the county election department's delay in tabulating and certifying the results of the 2008 election.

Voter campaign urged

To minimize the number of voters who failed to provide county elections with their current personal information, or did not follow voting instructions — and risk having their votes invalidated — the grand jury recommended the elections department conduct a vigorous and robust voter education campaign before each election "to deal with those prob-

,,,

"The department filled a vacant outreach position just this past September," Registrar Linda Tulett told The Pine Cone. "We are working on our outreach plan for the coming election season, which will include education on how to mark the ballot. "

The grand jury also suggested that the Monterey County Board of Supervisors and other elected officials in the county visit the elections department to become "thoroughly acquainted with the complex procedures in voter registration, validation of identity and vote tabulation that assures election integrity."

And the jury supported a request by county elections for a bigger, 25,000-square-foot building to house its operations, calling its current 11,000-square-foot facility "inadequate." The county pays \$20,600 every year to lease three storage facilities to store elections materials because it doesn't have enough space in its current building in Salinas.

for his significant other.

"I need a little gift for my wife," he told Williamson-Rocha.

"You mean Hillary?" Williamson-Rocha countered.

"You know her?" Clinton said with a grin.
"I've seen her on TV a few times,"
Williamson-Rocha deadpanned.

Testing Clinton's dietary resolve, the shopkeeper tempted him with something decidedly non-vegan.

"I tried to sell him some chocolate bacon toffee," she explained. "But one of the Secret Service guys said, "We're not allowed to eat chocolate."

According to Williamson-Rocha, Clinton appeared very fit.

"He's so lean now," she observed. "He looks fantastic."

While he was shopping, Clinton peppered Williamson-Rocha with questions about the shop and its farm in the San Joaquin Valley. She said he was interested in the farm's extensive use of solar energy and water conservation measures.

"He was so gracious," she said. "He real-

ly took the time to listen to what I had to say."

Williamson-Rocha said the Secret Service agents seemed to enjoy the visit as much the former president.

"The guys were a lot of fun," Williamson-Rocha recalled. "He seemed to treat them very well, and there was definitely a sense of camaraderie."

When it came time to pay, each of the Secret Service agents pulled out a Platinum American Express. "But the former president said, 'I got this, boys," Williamson-Rocha remembered.

The shopkeeper told The Pine Cone she'll cherish Clinton's visit to her workplace.

"He was so charismatic," she said. "He was just a super guy."

Remarkably, Williamson-Rocha had a brief encounter with another former president the same night.

"George W. Bush popped his head in and said, 'Good evening," Williamson-Rocha noted. "He seemed to be a hurry."

If the 43rd president of the United States had stuck around, the shopkeeper said she would have served him a meal he famously favors

"I could have made him the best peanut butter and jelly sandwich he ever had," she added with a laugh.

he bribed representatives of major food buyers such as Kraft and Frito Lay to pay inflated prices for tomato paste made by his company, SK Foods, which had operations in Lemoore and several other California towns, and was headquartered at Ryan Ranch. The company also routinely falsified lab test results for its tomato products, hid the fact that they contained excess mold, and pretended conventional produce was organic, prosecutors alleged.

While defense attorneys, the judge and even Salyer himself agreed that he was guilty, the judge opened the sentencing hearing Tuesday by saying he was unsure how much prison time would be appropriate for Salyer — in part, because it wasn't clear what his motive was. "Here's a millionaire who risked everything for nothing," Karlton said. "Was it because he thought he could do anything and get away with it simply because of who he was?"

One of Salyer's attorneys, Elliott Peters, responded by claiming that Salyer was "misled by some of his chief people" into embarking on his criminal schemes. He also said his childhood with an "abusive and hard-headed father and an alcoholic mother" led him to "make judgments that make absolutely no sense."

And while Salyer's "arrogance" was also to blame, Peters conceded, he has now become humble. "It's his fault, but he's a different man now and is tremendously chastened by what he's done," Peters argued.

But U.S. Attorney Segal attributed the downfall of Salyer, which led to the forced sale of his company and cost hundreds of employees their jobs, to other factors.

"He's been cheating in business for decades," Segal told the court. "He was disabled by his own character and surrounded himself with toadies and sycophants. He's a bad guy who surrounded himself with enablers."

Karlton said the sentence should not only punish Salyer, but also send a message to everybody in the food business to watch their step.

"It's remarkable how many people in this case were willing to take bribes without a second thought," the judge observed.

Then it was Salyer's turn to address the court. His voice shook as he began with an apology to his two grown daughters, who sat behind him in the courtroom, his former employees and his customers and suppliers.

"I regret my behavior and I take full responsibility," Salyer said.

He recounted the "explosive growth" of SK Foods after he acquired it from his father, Fred Salyer, in 1996.

"By 2007, SK was a leader in supplying tomato products all over the world," Salyer said

And the downfall that came after the FBI

uncovered his bribery and racketeering scheme was his fault, Salyer admitted. "The mistakes made at SK were mine and I take full responsibility for them."

He said the seven months he spent in the Sacramento County Jail before he was released on \$6 million bail in March 2010 were truly "hard time," and listed a series of health problems that resulted. "I'm 57 years old, and my life is over," he claimed.

But Salyer then asked for a lesser sentence by recounting his charitable efforts while he was wealthy, including helping Santa Catalina School in Monterey build a new aquatic center. "Giving back to society has been my proudest accomplishment," he said. "And with the court's leniency I can right my wrongs."

Restitution demanded

After a brief recess, Karlton sentenced Salyer to 72 months in prison, recommended it be served in the minimum-security federal prison in Lompoc, and ordered Salyer to surrender by April 9. He also put off until March 12 consideration of demands for restitution by some of the food companies that were defrauded by SK Foods, or harmed by its unfair competition.

The president of one of those companies, Chris Rufer of Morning Star, attended the sentencing hearing.

In dramatic and detail-filled court documents filed Monday, he said his company lost "an enormous amount of business" because of Salyer's bribery and price-fixing, and provided numerous specifics, including allegations that Salyer:

- Expressed a serious desire to have Rufer "run over by a truck" and asked an employee if he could recruit someone to do it.
- Hired numerous Morning Star employees and asked them to bring "confidential business information with them."
- Bribed Rufer's assistant to steal "confidential financial information" located solely on "Rufer's personal computer."
- Bribed purchasing agents from major buyers such as Kraft, Frito-Lay and Safeway to disclose Morning Star's bids, and to pay inflated prices for tomato products from SK.

According to Morning Star, Salyer also blamed Morning Star for "somehow orchestrating the government's investigation" of him — a claim, Morning Star said, which is "hardly the statement of someone claiming to be remorseful."

After the sentencing, Salyer left the courthouse without making a statement. But the man who put him behind bars, U.S. Attorney Benjamin Wagner, was outspoken.

"This is obviously a tremendous fall from power for a man who was one of the richest and most influential people in the agricultural industry in California," Wagner said. "He managed SK Foods down a path of criminality and racketeering that made corruption an everyday business practice, and today he reaped what he sowed."



appalling" will cause "irreparable harm" to the models' reputations.

Witten also asked a judge to compel The Pine Cone issue a "redaction and written apology in print." However, the judge deemed Witten's court filing was not in compliance with legal requirements, and the newspapers remained on distribution racks and online. The Pine Cone circulates 20,000 copies in print and is emailed to 11,000 subscribers each week.

Miller said he wouldn't have used "SLUTS" as the jump line for the story had he known it would have created an uproar.

"The Pine Cone did not call anybody a slut," Miller said. "And we apologize to anybody who thought we did."

In the Jan. 30 letter to the Carmel City Council objecting to the Vesuvio party and the publicity featuring models from Racey Promotions, Hardy said, "You might mistake them for sluts and whores in their black thigh-high boots, little black dresses abundantly overflowing with chest and hiked up to their *bleep* which also reveal thigh tattoos." She also questioned whether Pepe's party was appropriate for Carmel.

The Pine Cone received letters from about 10 people upset over the term and who criticized Pepe (see letters to the editor that begin on page 25A). It also received several in support of the newspaper and critical of Hardy. The party, which was attended by actor Bill Murray, according to Pepe, apparently went off without a hitch.

In one email message, the angry father of one of the Racey Promotions models called the story "tasteless" and blasted Hardy.

"Anyone that called kids working for a living 'whores' should be ran out of town," he wrote. "What right does a loud mouth, uneducated, idiot have to say this about tough kids and young adults? She think she's better then everyone?"

Comments on Racey Promotions' Facebook page, which features numerous photos of scantily clad young women in provocative poses, were mostly supportive of Phillips and her company's legal pursuits against The Pine Cone.

"All I can say is shame on you, Pine Cone," one woman wrote. "You ladies are awesome!!!"

"Mrs. Hardy needs to mind her own business," according to a man from Gonzales, "and The Pine Cone needs to do some research before they print the ramblings of a

bitter woman."

One young woman on the Facebook page defended The Pine Cone, saying the newspaper merely reported Hardy's beef with the models and the Vesuvio party.

"I don't agree with Hardy," the user wrote, "but I don't think the Pine Cone was wrong."

Others on Facebook said the article was good publicity for Racey Promotions and that its "girls were coming out of this smelling like roses."

The Pine Cone also received comments from numerous readers, including young women, who said they understood the wry nature of the "SLUTS" jump line and that they believed Phillips, Witten and Pepe were overreacting to the story.

On Wednesday, Witten issued a nearly 700-word "statement" that starts off with "Sexist comments and reckless journalism smacks of libel." The press release takes issue with the word "SLUTS," the placement of that word above the photograph of the women and the use of the picture without permission from its owner.

"The Pine Cone must be held accountable for its recklessness," Witten wrote. "The paper's actions have adversely impacted the lives of these young women living, learning and volunteering in our community."

While Witten claimed the high school girls in the photograph that appeared on the front page "are being tormented by other students," neither she nor Phillips responded to questions from a Pine Cone reporter requesting examples of how they had been harassed. None of the girls or women in the photograph were identified by name in the news article.

In a statement to The Pine Cone, Pepe called the word "SLUTS" above the photo of the models a "terrible choice." He also decried Hardy's words to the city council — which her attorney, Michael Stamp, said are legally protected under the state's public meeting laws.

"Carolyn Hardy's comments in her original email publication were harmful and defamatory to me, my family, my profession, my businesses and to my good-standing in the community," according to Pepe.

Meanwhile, Mayor Jason Burnett weighed in on the potential for more nightlife in Carmel — which is at the core of the debate between residents like Hardy and business owners such as Pepe.

"Carmel is beautiful during the day and beautiful at night," Burnett said, "and I'd love to see businesses stay open a bit later and more people enjoying Carmel during evening time."

Subcommittee chooses Trailside Cafe proposal over ag giant's for depot

THE OWNER of a Monterey restaurant seeking to occupy the city's historic train depot is a step closer to doing that after a city subcommittee chose his proposal over another.

Last week, the Waterfront Master Plan Subcommittee recommended to the Monterey City Council that Sean Allen's Trailside Café would be the best fit to occupy the old Southern Pacific Railroad station at the base of Fisherman's Wharf.

Trailside Cafe, currently at a location above Cannery Row, would move near Fisherman's Wharf. Allen's proposal also includes a visitors center, retail store featuring train and historical memorabilia and surrey bike rentals.

"There is so much history to share with the locals and tourists," Allen told the subcommittee Monday night at city hall. "I will be proud to share these stories and history with all those who are interested."

The retail store Allen has proposed would offer photographs, books and other railroad and Monterey related items. Light boards with historical photographs and touch screens will allow visitors to access history of the train depot and Monterey, he said.

Tanimura & Antle's proposed Wharf

Marketplace would feature fresh seafood, artisan bread, fresh flowers, wine, baked goods, a juice bar and vendors selling other items.

But Allen said the subcommittee was swayed by his proposal because he followed the city's guidelines for the project closer than T&A. Allen's business, he contends, would also cost the city less since he's not requesting the city make landlord improvements to the old building.

"T&A was asking for \$226,000 worth of landlord improvements from the city," Allen told The Pine Cone.

According to his proposal, Allen would pay \$4,108 per month per rent for the building.

While Allen said he was informed by Monterey city staff that only he, not T&A, would be allowed to present his proposal before the city council next month, he told The Pine Cone this week staff members changed their minds and will also allow T&A to present its proposal.

"This gives the losing proposal an equal chance at promoting their project, yet again," he said. "I sense a teacher's favorite and lots of politicking still going on."

The city council is expected to choose a project at its March 5 meeting at Monterey City Hall.



J.R. Martinez shares his motivational message with CHOMP

THREE EXPANSIVE movie screens came to life with sound and strobe as words loomed large: Brown Swan, Dream Big, Never Quit, Stay Positive, Believe & Achieve. As J.R. Martinez

Achieve. As J.R. Martinez loped out onto the stage, the words shifted to "actor, dancer, son, hope, born survivor, U.S. soldier, motivator, Iraq war hero." His audience erupted into applause.

Martinez had come to the Monterey Conference Center last month to address an audience of more than 500 at the annual meeting of the Community Hospital Foundation.

Looking at him, one can see the man has been burned. Watching him dance, one can tell nothing has singed his spirit. November 22, 2011, a

reported 20 million viewers watched Martinez accept the Mirror Ball trophy on season 13 of Dancing with the Stars. But it took a lot more than a sassy samba and a quick step to bring him to that moment of triumph.

At 19, Jose Rene (J.R.) Martinez was a strong, athletic, determined young man with his sights set on football as a way up and out of his circumstances. Having mapped his route to the NFL via college, he worked hard and applied for scholarships. When they failed to materialize, he took an alternate course of action and enlisted in the U.S. Army.

His mother was against it. A single parent from El Salvador who had already buried a child due to congenital disease, she had seen war and suffered loss. But she ultimately gave her blessing. Martinez enlisted in September 2002, one year after the events of Sept. 11, 2001. He considered Basic Training his college campus.

Six months later, he was deployed to Iraq. "The next thing I knew," said Martinez, "I

was sitting on an airplane with a weapon on my lap, heading to the Middle East. It was no longer a video game I played as a kid, a movie I could pause when it got scary, or me sitting on a front porch, hearing stories. This was my life."

Martinez's assignment was to provide security for other soldiers on a mission. Anyone who tried to attack them was going to hit him first. He loved his work; he felt good about his contribution

On April 3, 2003, Martinez was assigned to escort a convoy from the

southern part of Iraq toward Baghdad. He saw it as an ordinary assignment on an ordinary day. He got there safely. No big deal, he thought. He received new orders to secure an area north of the city. No big deal. He jumped into the driver's seat of his Humvee, and three others climbed in after. No big deal. All he had to do was follow the two trucks in front of him. No big deal.

"I drove with one hand on the steering wheel, casual, like I thought I was driving a Ferrari down Sunset Boulevard," he said. "Away from family, friends and freedom, we used humor to handle any fear. We were laughing. And then, 'Boom!' The front left tire had run over a bomb."

"How is it," asked Martinez, "that one

second I could have all these goals and ambitions, and the next second, I was screaming at the top of my lungs for someone to come get me as I felt the flames engulf my body and my dreams?"

His passengers were thrown free of the truck and walked away with minor injuries. He was trapped inside the inferno for five minutes before his sergeant could pull him out.

"I watched my hands change in the way we might see in those high-budget Hollywood films," Martinez said; "but in the movies, the actors return to their trailers, wash it all off, and go back to normal. I knew this was real. I felt it. I could feel my face, melting. Every time I tried to touch it, to follow my instinct to protect my face with my hands, my sergeant wouldn't let me. My lungs and other organs were damaged from smoke inhalation. I was gasping for air."

Once evacuated to a local medical station, Martinez was

placed in a medically-induced coma to avoid intolerable pain. Some 34 percent of his body had burned.

During the next three years of hospitalizations for 33 surgeries to rebuild his body, Martinez rode the waves of anger, regret and gratitude. Then he was asked to spend time with another burn patient deep in the darkness of his own devastation.

Later, he was asked to audition for a three-month stint on the All My Children television soap opera. He got the part, and turned it into a three-year role. And then he fell in love with girlfriend Diana Gonzalez-Jones. The couple welcomed daughter Lauryn Anabelle last May. Now, he has also penned his memoir, "Full of Heart," to encourage readers to overcome obstacles.

"Life is constantly changing, and we must all learn how to adapt and overcome," Martinez told his Community Hospital audience. "But life is not just about dealing with change. Every single one of us has the ability to make a difference in the lives of others. It doesn't matter who you are or if you feel your contribution is small. In the grand scheme of things, your gesture is essential."

CHOMP celebrates 1000 heart surgeries

A 38-year-old man this week became the 1000th person to undergo heart surgery at Community Hospital of the Monterey Peninsula.

Ezequiel Rodriguez-Chavez and his wife spent Valentine's Day at the hospital after doctors repaired a birth defect that left his heart barely pumping.

Cardiothoracic surgeon Gregory Spowart gave Rodriguez-Chavez a new valve and an aortic graft. The surgery Wednesday also marked the 6th anniversary of the founding of Community Hospital's heart surgery program and the Tyler Heart Institute, according to a CHOMP press release.

Rodriguez-Chavez found out when he was 18 that he had a hole in one of his heart valves, but he lived with it — until it nearly killed him, CHOMP said. He came to the hospital's emergency department on February 3, feverish, short of breath, and fearing he had pneumonia.

Doctors found that his heart was enlarged and weakened to the point that it was pumping at only 25 percent of normal — " a burned out heart," Spowart said.

"It was really surprising he did as well as he did for so long," Spowart said.

Rodriguez-Chavez, who has a car-repair business in Gilroy, is expected to go home in a couple of days, according to the hospital.

A COACH'S SUCCESS GOES FAR BEYOND THE GAMES HE'S WON

IT'S NEITHER the basketball victories — literally, hundreds of them — nor the league championships — and there have been many, including this season — that define coach Rich Frank. It is the type of person he is and the impact he has had on the lives of those he has taught and coached over the course of four decades on the Monterey Peninsula.

Frank is in his second time around as the boys basketball coach at Carmel High, where he has also coached the girls team.

At 68, he is a "gym rat" who savors the countless hours instructing and nurturing talent on a court.

Besides 17 seasons at Carmel High, where his son Chris is the new junior varsity baseball coach, Frank has coached at Seaside High, Monterey High, CSUMB, Leigh High in San Jose, King Middle School and for an AAU team in Seaside. There were also three seasons at the helm of professional teams in Denmark.

Frank has never taken a break from coaching of more than one year, and he still loves it. His courtside demeanor is calmer than it

was years ago. "I'm more reflective, not so intense, and better at deciding what's important in life, and in sports," he said. "I'm more patient. Each job has been different. All my life, even as a boy, I've enjoyed the diversity of life. And my friends are a very diverse group of people."

Frank arrived on the Monterey Peninsula in the fall of 1972, young and

somewhat cocky, to teach social studies and physical education and to coach basketball at Seaside High, his first head varsity position.

Frank, who grew up and learned his basketball in San Francisco and in college, felt at home in the multi-racial student and coaching world that was Seaside High.

"The coaches were people who didn't see color," Frank recalled. "They judged people on their character and their competency. We enjoyed each other's company. I still have a special place in my heart for Seaside High and many, many friends from there."

In his second season, Seaside won its first league title. Ron Powell was on that squad.

"We all thought that Rich was a crazy white guy from San Francisco," he reflected. "But he made us understand the



P.G. photographer illuminates the fading cultures of Latin America

OFFERING A fascinating look at indigenous people, their communities and their fading cultures, Pacific Grove photographer Jeffrey Becom presents a collection of his work, "Since Before the Moon Appeared: The Painted Legacy of Latin America," Saturday, Feb. 16, at the Museum of Monterey.

Since 1990, Becom and his wife, Sally, have traveled the backroads of Central and South America. Along the way, he has captured a way of life that is quickly disappearing. In particular, the photographer is drawn to traditional architecture and the rich colors painted on houses, churches and tombs.

The exhibit features 22 oversized photographs that illustrate — often dramatically — the effects of the modern world on remote Latin American villages and the people who have lived there for countless generations.

One photograph shows a boy in Honduras holding two bright green iguanas," Becom told The Pine Cone. "In the Mayan culture, iguanas were considered sacred — they were given to the high king to eat or they were sacrificed to the gods. In this photo, the boy is selling them to truckers to make tacos.

Wandering off the beaten path, Becom and his wife have visited many villages where the traditional way of life endures. "We've been to Guatemalan villages where they still use the Mayan Calendar to determine what days are good to travel, get married or plant their fields," he noted.

Traveling to remote parts of Latin America comes with a multitude of risks, including bad water, insect and snake bites, disease and locals wary of outsiders.

"We take a lot of precautions," Becom explained. "We bring along heavy-duty antibiotics and anti-parasite mediare careful to tread lightly.

'You just don't drive into a village wearing sunglasses," he observed. "They assume you're trouble. They don't like to see cameras, and they don't like to see foreigners. We park or







Long live the original hippie bread, Have a Heart, and beer at Fifi's

THERE'S ANOTHER side to Rich Pepe — one that doesn't have anything to do with tequila parties and models in short dresses.

When Pepe bought The Granary Natural Foods Store &

soup to nuts

Bakery in Pacific Grove in the mid-1970s, he "was a hippie with long hair down to my shoulders" who had grown up working in his uncle's New Jersey bakery. Transplanted to the West Coast, he took his family's

recipes and converted them to incorporate whole grains, replace refined sugars with malt syrup and honey, and incorporate other health-conscious changes. Out of that came the Granary Health Bread — a delicious and nutritious loaf that can now be found at Whole Foods Market in Monterey, but

Back in its original heyday, however, about five years after he bought the bakery, Pepe "had five cooks on the road selling 20,000 loaves a week," he said. He brought in a new partner, longtime friend and former 49ers player Bruce Elia, who was forced to retire from professional football due to injury, and the two worked together on the breads, which they named The Granary Health Breads by Pepe and Elia, until Elia returned to New Jersey and Orowheat bought the license for the bread.

When Pepe bought the old Wishart's Bakery on Ocean Avenue in 1986, he started using the same recipe for the sandwiches offered there.

Fast-forward to a few years ago, when Pepe was leading cooking classes at Whole Foods.

"The people there said, 'Let's get started selling that bread again," Pepe said, and he was amenable. "We wanted to keep the label alive, keep the bread alive."

Whole Foods in Monterey is the only place the Granary Health Bread Original Five Seed — sesame, flax, sunflower, poppy and pumpkin — can be found.

"It's our only account," he said. "Someday, we might expand it again, if one of my kids is interested in it. We eat it every day and still use it on our sandwiches at the bakery."

Compared to the 20,000 loaves of the early 1980s, Carmel Bakery now turns out 80 to 100 loaves a day. Whole Foods in Santa Cruz wanted to carry it, too, but Pepe wasn't sure he wanted to tackle the logistics of delivering it.

He's also reconsidering the "original hippie bread" part of the label, after a group of young business students suggested that might carry more of a negative connotation than a positive one in the 21st century.

"Hippies might be more associated with laziness and homelessness and drugs, so we might be reevaluating that," he said.

In the meantime, look for the unmistakable throwback label on sliced loaves on the shelves in the Whole Foods' bread section.



Schools3 to hold fundraising art sale

CIVIL ENGINEER and longtime Carmel resident Jon Raggett is working toward a significant milestone in the history of his nonprofit Schools3, which raises money to build schools in West Africa, Honduras and India: Construction of

And on Friday, Feb. 22, Raggett and his wife, Tory, an art teacher, will collaborate on an art sale to further Schools3's efforts. The sale, which will include her students' artwork in all different sorts of media — paintings, photographs, pottery — as well as celebrated local artist David Ligare and favorite historical figure Jo Mora, will be held from 4:30 to 7 p.m. in the former Coldwater Creek location in Carmel Plaza, which is donating the space.

"There will be wonderful Mali spirit dolls, and totes and pillows made from African fabrics," Raggett said. "There will be pottery, bracelets, and trinkets from the market in Bamako." Food and wine will help fuel participants' energy for shopping and socializing.

Every penny raised at the sale will go toward the construction of schools in developing countries, since all of the event costs and materials are being donated by Schools3 board members. Construction runs about \$18,000, compared with many times that number to build a school in the U.S.

"This event will raise money for our 60th school," Raggett

Schools 3 is a program of the nonprofit Development Engineering Research Institute, which Raggett founded in 1994 "with the mission to use all relevant engineering and technical means to aid development and to reduce poverty in developing countries." Raggett, who holds degrees from Princeton and Stanford, and specializes in wind dynamics, started DERI after being inspired by a Honduran priest who spoke at All Saints' Church about running an orphanage. He later created Schools3 and began building schools in 1999.

Schools3 has funded the construction of schools in India and Honduras, but its main focus is on Mali, and while North Mali has been recently subjected to violence at the hands of Islamist militants, Raggett's schools are in the south, nearly 800 miles across the Sahara Desert from the trouble.

get off a bus outside the village and walk in. Then, we sit in a church until someone approaches us."

Typically, Becom said, he and his wife will be approached by a Spanish-speaking local — often the only Spanish speaker in the village. Most of the locals only speak an indigenous language — hundreds of which exist in the region.

The locals embrace a far more communal existence, Becom explained. Competition is frowned upon. As a result, if one person learns Spanish and can serve as a translator, there's no need for anybody else in the village to speak the language. It's the same way with personal belongings.

If one person in the village owns a truck, everybody uses it," he said. "If someone ends up with more than anybody else, people become jealous, and they'll send a witch in the middle of the night to make that person sick or die. In traditional villages, you don't want to stand out in any way.'

While Becom and his wife have had a few close calls with local authorities, he said the rewards of their adventures outweigh the risks. "It can be tense at times, but mostly it's been a series of amazing experiences."

Ultimately, Becom hopes to preserve — at least in photographs — indigenous cultures before they're gone. And he strives to do it with the detail of a scholar and the eye of an artist. "I look for places where the traditional way of life still exists where there's a direct connection to the pre-Columbian expressions of history and culture," he said. "What I do is a balance between documentation and fine art."

Also an accomplished painter, Becom's work is displayed at the Carmel Art Association, and at the Weston Gallery.

tory."

As part of the deal, the county agreed to pay \$24,000 to the Carmel Valley Association for attorneys' fees. The Carmel Valley nonprofit previously received \$36,000 from the county to cover legal expenses in the same case.

The lawsuit was one of four lawsuits filed Nov. 24, 2010. Each one targeted policies in the new general plan, which was adopted in October 2010 after more than 15 years of

The settlement agreement was reached following 18 months of negotiations. Carl Holm, deputy director for the Monterey County Resources Agency, told the supervisors the agreement represents a fair deal for both sides. "Nobody got everything they wanted," said Holm, who said a failure to approve the settlement "would be a shame and not in the public's interest."

But builder Brian Clark argued there is little threat of overdevelopment in Carmel Valley — and as a result, no need to amend the general plan.

"The census says Carmel Valley's population has dropped," Clark said. "Traffic is down and real estate prices are depressed. Nobody is moving to Carmel Valley."

Clark suggested that instead of making it more difficult to build in Carmel Valley, "we should be rolling out the welcome mat."

Attorney Pam Silkwood also urged supervisors to nix the deal, saying the lower cap "discriminates against low income residents and minorities." "By limiting housing in Carmel Valley, you're limited the authority of future boards [of supervisors]," Silkwood

But Carmel Valley resident John Dalessio took aim at Silkwood's comments, calling her statements "a lot of garbage." He also insisted affordable housing is available in Carmel Valley, "but most of it is illegal."

Dalessio asked supervisors to agree to the settlement, in part because he said Carmel Valley is too hazardous for more development. In particular, he cited the risks of earthquakes, floods and wildfires.

"There's one road in and one road out," Dalessio said. "You don't want a lot of emergency vehicles on that road. It's a disaster waiting to happen. You don't want to add people to the area."

Supervisor Dave Potter, who represents Carmel Valley, called the settlement "a significant improvement for the greater community of Carmel Valley."

"This is a rather historic moment," he suggested. "Intelligent and conflicting minds can come to agreement. We've done well here."

Other than Potter's words, no supervisor offered any comment about the settlement. The supervisors' decision stands in stark contrast to the view taken by the Monterey County Planning Commission, which unanimously agreed not to endorse the settlement agreement just three months ago. Planning commissioner Martha Diehl — whose district includes Carmel Valley — objected to the idea of putting a cap on new units in the Carmel Valley Master Plan Area. According to Diehl, the cap of 266 units "was negotiated with everyone involved." "There's nothing to persuade me that the 76 units here are worth voiding that agreement," she said.

In addition to reducing the cap on new units, the settlement establishes new guidelines for counting traffic along Carmel Valley Road, and consequences for increasing traffic counts and degrading levels of service. The agreement reestablishes restrictions on removing redwoods, oaks and madrones, and prohibits non-agricultural development on slopes greater than 25 percent with highly erodible soil.

Carmel Valley Association attorney Ron DeHoff was happy with the settlement of the lawsuit. "We are delighted and feel this is a win for the residents of the county and Carmel Valley," he said.

While the supervisors agreed to amend the plan — and seemingly settled the dispute DeHoff said it's still possible for an individual or group to contest the agreement.

■ 75 years ago - February 18, 1938

Monoxide Kills Youth

What is believed to be the first case of carbon monoxide poisoning on record in Carmel was reported this week. The victim was Robert Lawrence Tatum, 19-year-old Salinas Junior College student, driver of the junior college bus from the peninsula to Salinas.

For his room at the home of Mrs. A. B. Palmer, Second and Monte Verde, Tatum had bought and installed a secondhand gas heater. It was not vented, as required by the gas code in force in Carmel. Apparently young Tatum came in after his Friday night run, cold, wet and tired, lighted the gas and lay down on his bed to rest. The room was tightly closed, and all oxygen was quickly consumed. When Mrs. Palmer called her roomer about 9 o'clock that evening, she received no response. She opened the door, discovered the tragedy, and notified the police.

The youth had come down here from Joplin, MO, about five months ago. His relatives are all in Joplin, and the body was to be sent there for burial.

■ 50 years ago - February 14, 1963

Councilman Whitaker Resigns

Councilman Francis Whitaker yesterday tendered a letter to Mayor Eben Whittlesey and the city council stating that he intends to move to Colorado approximately May 1, 1963, and has no alternative under the circumstances but to offer his resignation from the council effective at the adjournment of the April regular meeting.

Downtown Parking Game

With the advent of the rains have come the inevitable barrage of calls to the police department to inquire if the parking-beat officer was on the job with his piece of chalk.

The department has changed its answer this year. Instead of a "yes" or "no," the caller is advised of the time limit for parking.

The reason the bike officer is not sent out on his rounds in the rain is not that he is afraid of the wet but because of the soggy fact that the rain washes off the chalk marking and the



ticket sometimes placed under the windshield becomes too blurred to read.

Overtime parking citations are issued at an average or five or six hundred per month and a never-ceasing game is played between the merchants and the officer on duty: the merchants wait until the last minute before changing their parking spot, and the officer waits until the last minute before issuing a citation.

Resident merchants and their help take most of the parking spots on Ocean Avenue and were the instigators of the parking laws supposed to clear spaces for possible shoppers. But they resent a ticket like a kick in the pants.

■ 25 years ago - February 18, 1988

Rebuilding process for destroyed temple

Late Sunday night and early Monday morning a blaze raced through the 15-year-old Sambosa Korean Buddhist Temple, located about six miles into Carmel Valley off of Robinson Canyon Road, causing about \$250,000 in damage.

"We will definitely rebuild the temple but we might build a traditional temple," said board member Sukchoo Kim. The former temple was constructed mainly of wood, while a more traditional temple would be built of stone or concrete. Needless to say, churchmembers will attempt to build a less expensive structure, with insurance coverage coming in at only \$160,000, or \$90,000 short of the assessed damages.

The cause of the fire is still under investigation, according to Mid-Carmel Valley Fire Marshall Sidney Reade. Kim says he believes that someone used the temple late at night and lit a candle, neglecting to extinguish it after he left the building.

Also weighing heavily on churchmembers is the loss of irreplaceable artworks destroyed in the fire. Among those items were three golden-colored statues of Buddha and three large paintings that were placed behind them. "One of the statues is a national treasure in Korea," Kim said. "We cannot place values on the artifacts because they are priceless." Also lost in the fire was a set of Buddhist books originally written in Sanskrit, which had been translated into English.

game of basketball. He broke it down. He took a group of athletes, and he made us basketball players."

The two formed a deep bond, Powell serving as Frank's assistant for about a dozen years — at Seaside, Monterey and Carmel high schools.

Powell's son R.J. played for Frank, where he was outstanding and earned a basketball scholarship to Pepperdine.

"The reason R.J. came to Carmel High was because of Rich Frank," said the elder Powell, currently boys varsity basketball coach at Marina High.

Former CHS varsity coach Hans Schmidt, Frank's assistant coach, said of him, "There's just a kind of confidence from growing up in San Francisco in the 1960s. He has wisdom and street smarts that are real hard to come by in this

In Frank's first year back last season, Carmel won the Mission Trail Athletic League title, and he was chosen league Coach of the Year.

"I've coached two years at the college level and I played four years in college," Schmidt said. "Rich's knowledge of the game is far greater than anybody I've been around."

There's more.

"It's his understanding of the teenage male, including dealing with the day-to-day nonsense that comes up,' Schmidt said. "Rich has seen it all. Wherever a kid is at emotionally, he can meet him there."

"He really does care about all the guys on the team," said UCLA freshman Matt Rudolph, who played for Frank's freshman, junior varsity and varsity teams at Carmel. "It's not just about basketball. He cares how people are doing in the classroom and how they are doing on campus."

Retired from classroom teaching, Frank has no interest in a life without coaching.

"It's something that I enjoy doing," he said matter-of-factly. "I take that at face value."

What defines a good year?

"If we're playing better as the season progresses," Frank said. "The won-loss record doesn't have a lot to do with it. If you're concentrating on the process, on what you do and how you do it, then what you want to get done will be more than likely to happen."

As far as this season's won-loss record, it's excellent. Entering the Mission Trail Athletic League tournament, which begins Feb. 14, the Padres are 16-8 overall and finished first in the league at 11-2.

A serious overreaction

No, WE'RE not talking about the angry response that came from a few people to our use of the word "slut" as a jump line in last week's Pine Cone. That part of the tempest that broke out after our coverage of the controversy over a provocative party at a downtown restaurant is addressed in our front page story and clarification.

This editorial is about what started the whole thing: Carolyn Hardy's nearhysterical reaction to the party and the sexy models used to promote it and help draw a crowd.

Based on a few photos, she foretold that parties like the one at Vesuvio Thursday night would lead to an epidemic of wild partying and even prostitution in Carmel — an assertion that is absurd, to say the least.

Right now, nearly every evening, Carmel is as quiet as a meeting of the NRA branch of the Barack Obama Fan Club. Literally, throughout downtown, by 8 or 8:30 p.m., almost nothing is going on.

That suits some people just fine. But to most residents and visitors, a little activity that lasted until 9 or even 10 would be welcome. Some music to listen to, and people to meet, and the chance to have a bite to eat if you've been working late or are just hungry — such things sound wonderful to us and, as we say, to most Carmel residents and visitors.

Of course, the town has strict noise ordinances already, and a diligent police force, so there's no danger things will get out of hand. Likewise, prostitution is already illegal. And so is public drunkenness and nudity. And the streets are too cold for anybody to want to make a ruckus outdoors for more than a few minutes. Truly, there is nothing to fear from a little more nightlife in town, and the people who are trying to bring it about are to be congratulated and helped.

Nevertheless, as always happens when there's a hint of change in town, the same small group of narrow-minded obstructionists start getting unhinged. Over the last 15 years, that happened when there was a proposal to loosen the tree ordinances slightly ("soon we'll have no trees!"), a coffee shop asked for permission to sell soup ("the town will be overrun with fast food!"), the Pine Cone planned to move its offices into an aging motel ("the residential district is being violated!"), and the council decided to sell Flanders Mansion ("there go our parks!"). Etc., etc., etc.

When the activists start going hyperbole crazy, you can bet it's because they know they're in the minority, and that predicting doom is their last hope to win a few more (uninformed) supporters.

Since it was founded in 1916, Carmel has been different every year than it was the year before. Meanwhile, people with no common sense insist that laws must be passed to prevent it from being changed one iota from the way it was

Of course, Carmel is charming and quaint and wonderful. But it is not perfect, and with a little more nightlife, it would be better.

The CPUC has set a deadline to receive testimony from those involved in the public process by Feb. 22. Evidentiary hearings are scheduled for April at the PUC's San Francisco offices. And Carmel Mayor Jason Burnett said he hoped there wouldn't be much dissent there.

"It will improve our ability to have an influence with the CPUC if we have this community united in our position," Burnett told the water board.



"I grew up 16 years in Japan. There is no self. There's only us, the cumulative us. That is ingrained in me. Inside me, this blondhaired, media writer, author, speaker that's all over the world is this Japanese person who is saying, 'We can all be better. We have to all dialogue. We have to lift our society up.' This is my whole mission in life. I have no personal desire for fame, for acknowledgment, for money. These things don't juice me up. I write for service."

But then we talked about her book. She researched "The Watchman's Rattle" for six years, and then wrote it in three months.

"I didn't eat, I didn't shower for days, I didn't give a crap about turning the heat on in my house. All I wanted to do was write. I

wanted to sit and write. I wouldn't answer my phone. My friends, who love me, were coming to the house and quietly opening my front door and filling my refrigerator with food. They knew something was happening.

"I really thought I would be institutionalized. At the end of it, I celebrated by drinking two shots of tequila, and I wound up in the emergency room at CHOMP because I was so dehydrated and my body was like a sponge and it soaked up the tequila. Who knew?"

And, "When I was done with the manuscript, I had no idea if it was a piece of lunatic crap or it was brilliant, but I knew it was the truth. That's the only thing I knew."

Rebecca startles interviewers when she doesn't take credit for the book. She said she transcribed it, taking dictation from her muse. But in fact, that's what can happen. It's both exhilarating and exhausting. But when it's all done, you feel well-used.

When she's not writing or on the radio or speaking to attentive audiences or setting up a series of authors' nights, she's not resting. For three decades, she has been a first



responder for the Red Cross, arriving on the scene of disasters within 24 hours. Her mantra is to be happy to do the work. She often will support the crews doing the heavy lifting by singing opera, and making them happy by giving them a laugh about what

She says she can't sing very well and she often forgets the words, but since she's singing in Italian, who knows, and anyway, they let it slide.

Edwin Ladd Lundblad, 93, died peacefully on Saturday, February 9, 2013, in Carmel, California surrounded by his family.



Born on January 3, 1920 in Linden, CA, Ed was the eldest son of Paul and Jeanette (Ladd) Lundblad. He served during World War II in the U.S. Army military police. Ed was stationed in the Solomon and Russell Islands, and was in Guadalcanal during the 1942 campaign. Later, he was stationed in the Philippines and was a member of the occupational forces in Japan in 1946.

Following his military service, Ed attended the California School of Arts and Crafts in Oakland, CA. He moved to Carmel, California in 1947 to build houses in order to fund his education and
